Per our conversation yesterday, attached are the analytical reports you need for the subject remediation project. The first report is the groundwater sample from MW-4 taken 9/25/08. The other two analytical reports document the sampling performed on the onsite stockpiled material.

In order to advance this site to obtain closure, Plains is requesting approval to perform the following actions:

- 1. Plug and abandon the existing onsite monitoring wells
- 2. Line the excavation per the approved abatement plan
- 3. According to the agreement made with the landowner, utilize the existing on-site soils as backfill material

4. A final site closure report will be developed documenting remedial activities and include a final C-141

Upon you approval, these actions will be implemented. Let me know if you need additional information to help you in your determination of this proposal.

The New Mexico Oil Conservation Division (OCD) has received Plains' report and request to plug the groundwater monitoring wells at the above-referenced site (dated, April, 2008) and subsequent report (dated, April 15, 2010). The above-referenced reports, submitted in partial fulfillment of 19.15.30.19 NMAC (Part 30.19, formally, Rule 19.K), indicate that Plains has partially met the requirements of 19.15.30.9 NMAC for this site. Therefore, the OCD hereby conditionally approves the Plugging Request for the TNM 97-23 Release Site and no further groundwater monitoring is required for this site.

The material used to plug the remaining groundwater monitoring wells at the TNM 97-23 Release Site must be a cement grout with 1% to 3% bentonite or other plugging material approved by the OCD. Please submit to the OCD a final plugging report within 60 days.

Plains must proceed with the approved abatement plan within 30 days. Please submit to the OCD a final site closure report within 120 days.

Please be advised that OCD approval of this report does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment.
