Dear Mr. Conder:

The New Mexico Oil Conservation Division (OCD) has received the Ground Water Monitoring Report for Abatement Plan (AP-59) for the Vacuum F-35 and G-35 Sites, dated October 7, 2010 and has conducted a review of the Report. The Report indicates that Rice Operating Company (ROC) has met the requirements of OCD Part 30 (formerly, Rule 19) for a Stage 1 & 2 Abatement Plan. Therefore, the OCD hereby conditionally approves the proposed corrective actions for above-referenced sites in accordance with 19.15.30.16 NMAC:

ROC must plug the two groundwater monitoring wells (MW-2 at both sites) with a cement grout of 1% to 3% bentonite or other material approved by the OCD. Please submit to the OCD a final plugging report within 120 days.

Please be advised that OCD approval of this report does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the owner/operator of responsibility for compliance with any OCD, federal, state, or local laws and/or regulations.
