Dear Ms. Swanner:

Reference is made to your application dated September 25, 1995 for an unorthodox Blinebry gas well location in an existing 160-acre standard gas spacing and proration unit ("GPU") for said Blinebry Oil and Gas Pool comprising the SE/4 of Section 11, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico. Said GPU is presently simultaneously dedicated, under the authority of Division Administrative Order SD-93-3, dated November 30, 1993, to the following described three wells:

- S.E. Long Well No. 5 (**API No. 30-025-10206**), located at a standard gas well location 660 feet from the South line and 1880 feet from the East line (Unit O) of said Section 11;
- S.E. Long Well No. 8 (**API No. 30-025-10209**), located 1650 feet from the South line and 2310 feet from the East line (Unit J) of said Section 11 (this location is considered to be unorthodox, however Rule 2 of the Special Rules and Regulations for the Blinebry Gas Pool, as promulgated by Division Order No. R-610, "grandfathered" this location in as conforming to the rules); and the
- S.E. Long Well No. 7 (**API No. 30-025-10208**), located at a standard gas well location 1780 feet from the South line and 660 feet from the East line (Unit I) of said Section 11.

It is our understanding that the subject well in this application is currently completed as a Drinkard oil well; however, said well will be plugged back and re-completed up-hole into the Blinebry Gas Pool upon issuance of this order.



By authority granted me under the provisions of Rule 2(c) of the "*General Rules For The Prorated Gas Pools of New Mexico/Special Rules and Regulations For The Blinebry Oil And Gas Pool*", as promulgated by Division Order No. R-8170, as amended, the following described well located at an unorthodox Blinebry gas well location is hereby approved:

*S. E. Long Well No. 6
660' FSL & 560' FEL (Unit P) of said Section 11
API No. 30-025-11373*

Also, you are hereby authorized to simultaneously dedicate Blinebry Gas production from the S. E. Long Well No. 6 with the S. E. Long Well Nos. 5, 7, and 8. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from all four wells in any proportion.
