(7) its existing Bertha Barber Well No. 15 (API No. 30-025-32532), located at a standard infill gas well location for this GPU 990 feet from the North line and 1980 feet from the West line (Lot 3/Unit C) of Section 5, which was also the subject of Division Administrative Order SD-94-1.1; and

(8) its proposed Bertha Barber Well No. 19 to be drilled at a standard infill gas well location for this GPU 2220 feet from the North line and 1972 feet from the West line (Unit F) of Section 5.

Marathon is hereby authorized to simultaneously dedicate Eumont gas production from itsproposed Bertha Barber Well No. 19 with the existing Bertha Barber Wells No. 4, 8, 10, 11, 13, 14, and 15. Furthermore, Marathon is hereby permitted to produce the allowable assigned the subject 320.56-acre GPU from all eight wells in any proportion

All provisions applicable to the subject GPU in Division Administrative Orders NSL-3203 (SD), NSL-3203-B (SD), SD-94-1, and SD-94-1.1, not in conflict with this order, shall remain in full force and affect until further notice.

Jurisdiction of this matter shall be further retained for the entry of any such subsequent orders, as the Division may deem necessary.
