Dear Mr. Tiss:

Per your application dated December 31, 1993, you are hereby authorized to simultaneously dedicate Eumont Gas Pool production to the previously approved non-standard 160-acre gas spacing and proration unit comprising the SE/4 of Section 30, Township 19 South, Range 37 East, NMPM, Lea County, New Mexico (Division Administrative Order NSP-36, dated December 15, 1954), from the existing Elliott State Well No. 4 (API No. 30-025-05756) located at a standard gas well location 660 feet from the South and East lines (Unit P) of said Section 30 and from the proposed Elliott State Well No. 6 (API No. 30-025-32381) to be drilled at a standard gas well location 1740 feet from the South line and 1980 feet from the East line (Unit J) of said Section 30.

Further, you are permitted to produce the allowable assigned said non-standard 160-acre unit from both wells in any proportion.
