Please find attached a remediation work plan request for the 5/19/10 release at or near Devon's West Red Lake Unit 1 site. While OCD encourages immediate response efforts on the operator's part to mitigate damages due to releases, please contact OCD as soon as possible to notify and/or discuss appropriate remedial actions. In most instances, OCD will require delineation sampling be performed at release sites. Also be aware that OCD rules require immediate (within 24 hours of discovery) notification of any release of produced fluid 25 bbls or over. When submitting the C-141, please include as much information as possible, but at a minimum, include the section, township and range of the well or release site.
