

Chevron U.S.A. Inc. respectfully requests administrative approval for simultaneous dedication of the Mark Owen Well No. 5 with the Mark Owen Wells Nos. 3, 4, & 6.

Chevron U.S.A. is planning to recomplete the Mark Owen #5 into the Blinebry Gas Pool. The well currently is completed in the Drinkard Pool. The location of the proposed recompletion is 660' FSL and 660' FEL in Section 34, T21S, R37E, Lea County, New Mexico.

The Mark Owen wells Nos. 3, 4, & 6 are dedicated to a standard 160 acre Gas Proration Unit which consists of the SE/4 of Section 34, T21S, R37E. This-was approved January 9, 1995 under Administrative Order NSL-2997-A(SD). Well-No. 3 is located 1980' FSL and 960' FEL (Unit I) Section 34, T21S, R37E. Well No. 4 is located 2068' FSL and 2068' FEL (Unit J) Section 34, T21S, R37E. Well No. 6 is located 554' FSL and 2086' FEL (Unit O) Section 34, T21S, R37E.

Well No. 5 was drilled in 1947 as a Drinkard producer. The Tubb was completed in 1954 and placed on dual production (Drinkard/Tubb). The Tubb was plugged in 1974 with production continuing from the Drinkard.


