Yates Petroleum Corporation, pursuant to the provisions of Division Rule 104 D (2)(b) and (c) adopted on January 18, 1996, hereby seeks administrative approval of a 165.90-acre non-standard gas spacing and proration for the Bobwhite "BBH" Federal Com. Well No. 1 to be comprised of all of partial Section 3, Township 6 South, Range 26 East, N.M.P.M., Chaves County, New Mexico. A non-standard 165.90-acre spacing unit comprised of this acreage was originally approved by Division Administrative Order NSP-1415 dated June 29, 1984. This non-standard unit was dedicated to this well (previously called the James "YY" Federal Well No. 1) in the Abo formation, Pecos Slope-Abo Gas Pool. The well no longer produces from the Abo formation.

Yates proposes to re-enter this well and drill it to the basement formation and test all formations below the top of the Wolfcamp formation which includes but is not necessarily limited to the Wolfcamp, Cisco and Strawn formations. Yates therefore seeks approval of this non-standard unit in all formations below the top of the Wolfcamp formation which, pursuant to



the General Rules and Regulations of the Oil Conservation Division, are developed on 320-acre spacing.

This non-standard gas spacing and proration unit is necessary because of a variation in the legal subdivision of the United States Public Land Surveys. This unit is comprised of contiguous lots that lie wholly within a single governmental section and are joined by a common side. Attached is a plat that shows the subject spacing unit and all adjoining spacing units or leases. Also attached is a list of all parties affected by this application.

Since this non-standard spacing and proration unit comprises all of partial Section 3, there are no owners in the mineral estate who are excluded from this non-standard unit. On or before the date on which this application was filed with the Division, a copy of this application with all attachments thereto was mailed to all offset operators or mineral interest owners by Certified Mail--Return Receipt Requested. Each of these parties was advised that if they have an objection to the proposed non-standard spacing or proration unit it must be filed in writing with the Division's Santa Fe office within twenty days from the date notice was sent. They were also advised that if no objections are received by the Division within twenty days, the Division Director could approve the application.

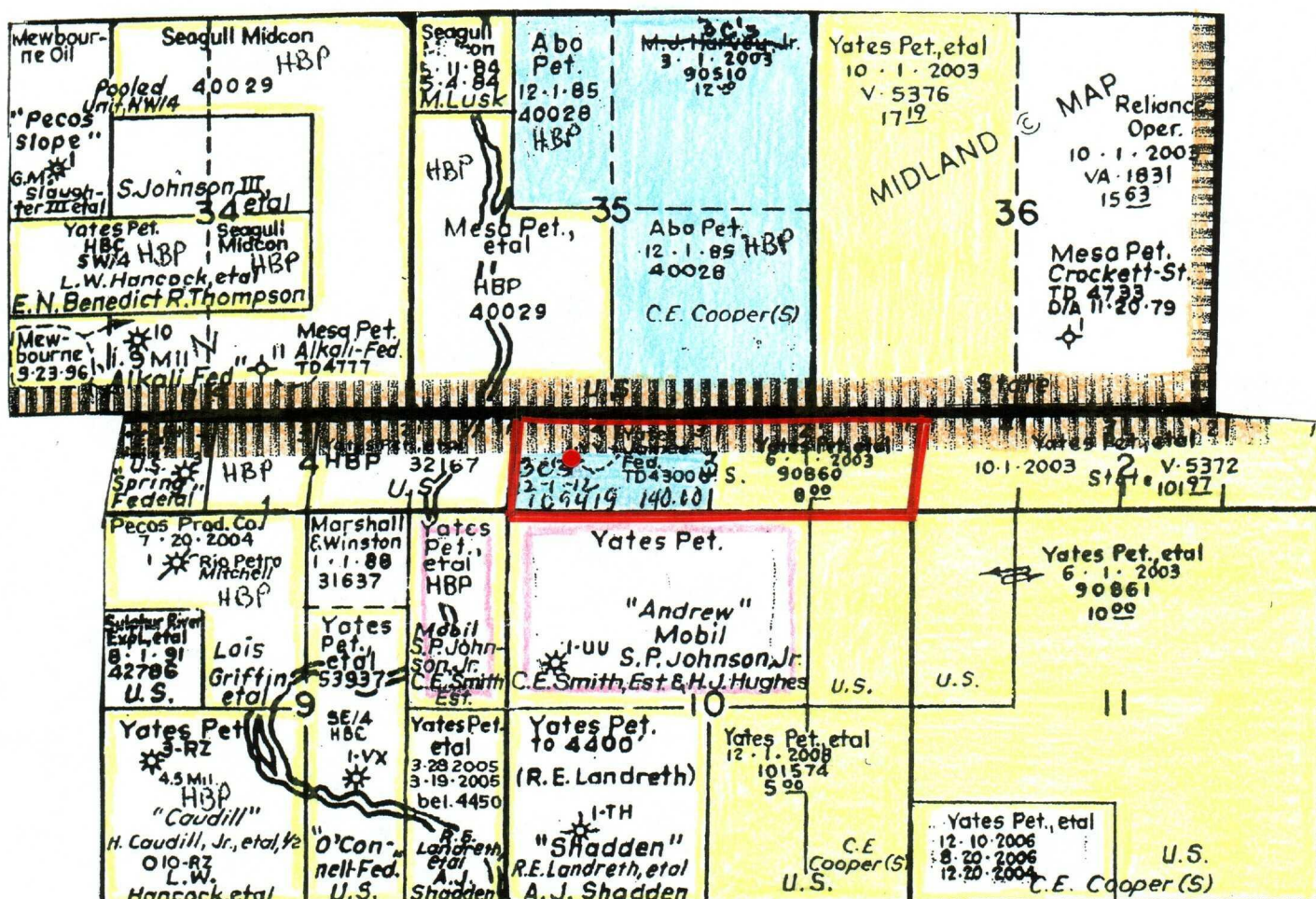
