Gentlemen:

Aztec Oil & Gas Company hereby submits its application for administrative approval of a non-standard gas proration unit comprising the NW $\frac{1}{4}$ (or E $\frac{1}{2}$ NW $\frac{1}{4}$; Lot 1; Lot 2) of Section 19, Township 28 North, Range ~~28~~ West, N.M.P.M., San Juan County, New Mexico, and in support thereof respectfully states and shows the following:

1. That the Aztec-Brink No. 2 Well, located 660 feet from the North line and 660 feet from the West line of Section 19, Township 28 North, Range ~~28~~ West, was completed May 15, 1936 as a gas well and connected to Southern Union Gas Company's pipeline.

2. That the proposed non-standard gas proration unit consists of 164.30 acres which are contiguous quarter-quarter sections and lots.

3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.

4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

5. That so far as is known to Applicant, the following companies constitute the only operators, other than Applicant, owning an interest in any of the acreage included in or offsetting the proposed unit, and such companies are being notified by registered mail of this proposed non-standard gas proration unit by the mailing of a copy of this application to each of them:
