Gentlemen:

The M. S. B. W. Company, Robert L. Maddox operator, hereby submits its application for administrative approval of a non-standard proration unit comprising the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) and the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Twenty-Eight (28), Township Thirty (30) North, Range Twelve (12) West, N.M.P.M., San Juan County, New Mexico, said proration unit being in the Fulcher-Kutz Pictured Cliffs Pool, and in support thereof states the following facts:

1. The M. S. B. W. Company No. 1 Montgomery well (patented land) is located 3300 feet South of the North line and 3300 feet West of the East line of Section 28, Township 30 North, Range 12 West, N.M.P.M., San Juan County, New Mexico, and was completed as a gas well in January, 1948, and connected to the Southern Union Gas Company line in January, 1948.

2. That the proposed non-standard gas proration unit consists of eighty (80) acres which are contiguous quarter-quarter sections.


3. That the proposed non-standard gas proration unit lies wholly within the boundary lines of Section 28, Township 30 North, Range 12 West, N.M.P.M.

4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

5. That by a copy of this letter of application all operators owning interests in said Section 28, in which this non-standard proration unit is situated and which acreage is not included in said non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.

6. Therefore the M. S. B. W. Company requests that under the provisions of Rule 6 (a) revised, Order R-565, the Secretary of the Commission grant exception to Rule 6(a) without notice and hearing and approve the subject non-standard gas proration unit.
