Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the West Half (W/2) (or NE/4 NW/4, SE/4 NW/4, NE/4 SW/4, SE/4 SW/4, Lots 1, 2, 3, and 4) of Section 18, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

- The Sharp #1 Well, located 990 feet from the North 1. line and 990 feet from the West line of Section 18, Township 28 North, Range 8 West, was completed as a gas well on January 15, 1951, and connected to El Paso Natural Gas Company's gathering system March 3, 1951.
- 2. That the proposed non-standard gas proration unit consists of 304.52 acres which are contiguous quarterquarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said nonstandard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed nonstandard gas proration unit.


