El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the Northeast Quarter (NE/4) (or SW/4 NE/4, SE/4 NE/4, and Lots 1 and 2) of Section 3, Township 29 North, Range 11 West, San Juan County, New Mexico, and in support thereof states the following facts:

- The Martin Pool Unit #3 Well, located 1650 feet from the North line and 1650 feet from the East line of Section 3, Township 29 North, Range 11 West, was completed as a gas well on June 23, 1953, and connected to El Paso Natural Gas Company's gathering system July 23, 1953.
- 2. That the proposed non-standard gas proration unit consists of 145.47 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


