of Order No. R-128-C for Non-Standard
Proration Unit, Blanco Mesaverde Gas
Pool, Rio Arriba County, New Mexico.

Gentlemen:

El Paso Natural Gas Company, as Unit Operator of the San Juan 29-7 Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising the East Half (E/2) (or Lots 5, 6, SW/4 NE/4, SE/4 NE/4, NW/4 SE/4, NE/4 SE/4, SW/4 SE/4, SE/4 SE/4) of Section 4, Township 29 North, Range 7 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The San Juan 29-7 Unit Daum #2-A Well, located 990 feet from the North Line and 1650 feet from the East line of Section 4, Township 29 North, Range 7 West, was completed as a gas well July 23, 1953, and connected to El Paso Natural Gas Company's gathering system August 16, 1953.
2. That the proposed non-standard gas proration unit consists of 317.38 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


