Gentlemen:

El Paso Natural Gas Company, as Unit Operator of the San Juan 28-7 Unit, hereby submits its application for administrative approval of a non-standard proration unit comprising the East Half (E/2) (or Lots 1, 2, NW/4 SE/4, NE/4 SE/4, SE/4 NE/4, SW/4 NE/4, NW/4 NE/4, NE/4 NE/4) of Section 36, Township 28 North, Range 7 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The San Juan 28-7 Unit #11 Well, located 1100' from the North line and 1190' from the East line of Section 36, Township 28 North, Range 7 West, was completed as a gas well on October 21, 1953, and connected to El Paso Natural Gas Company's gathering system on March 4, 1954.
2. That the proposed non-standard gas proration unit consists of 328.06 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.

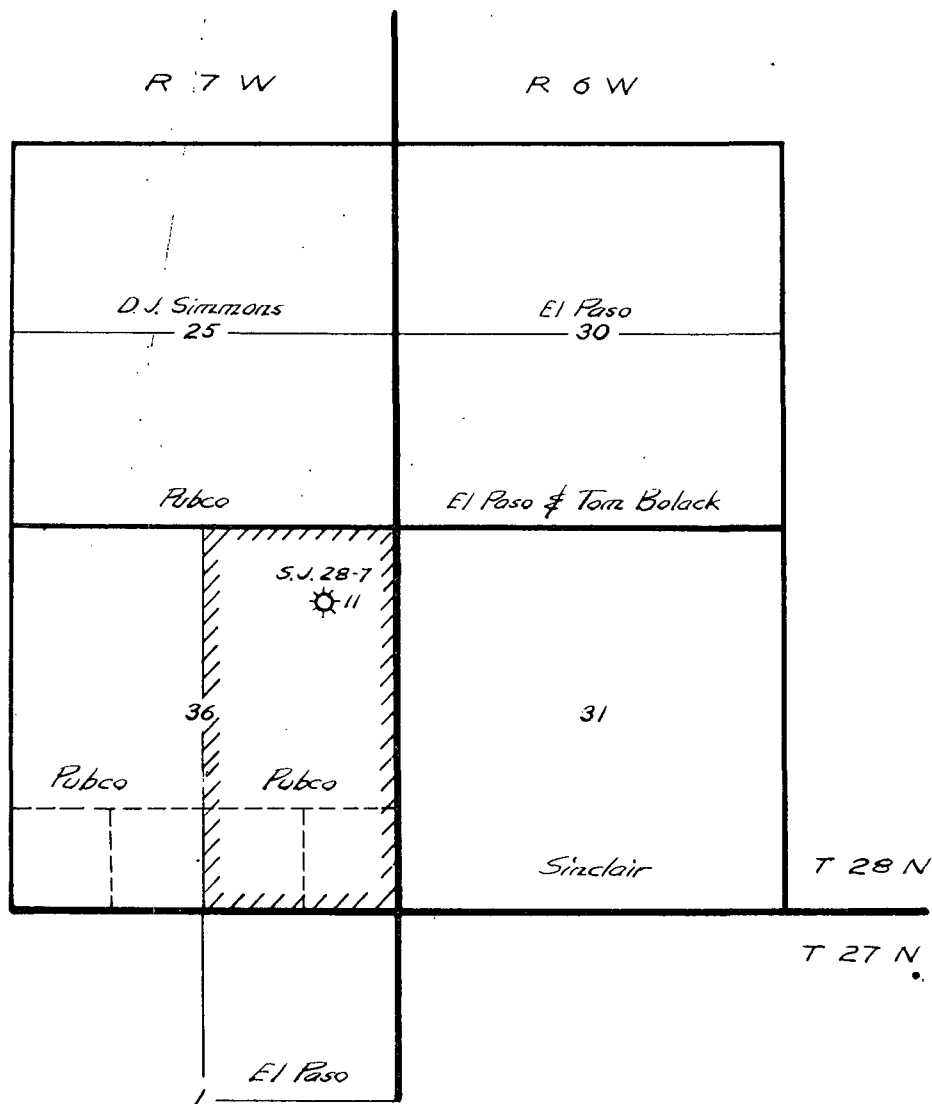
