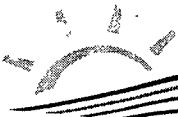

State Agency Responsible for Leasing: New Mexico State Lands Office (see US Bureau of Land Management links below for Federal lease information)

Leasing: Leases are available on a non-competitive basis. However, the Commissioner of Public Lands may at his discretion reject any application and offer the tract or tracts at public auction. Lands classified as “known geothermal fields” are leased through public auction through either sealed or oral bidding procedure.

Lease Terms:

Primary: 5 years

Renewal: Primary term can be renewed for additional 5 years and thereafter so long as geothermal resources are being produced or utilized or are capable of being produced or utilized in commercial quantities.

Rentals: \$1.00 per acre or fraction thereof per year (escalates to \$5.00 per acre per year after primary lease term).

Royalties: 10 % of the gross revenue from the sale or use of steam, brines or hot water, associated gases or other forms of heat or energy derived from production with a minimum of \$2.00 per acre or fraction thereof per year. A royalty of not less than 2 % nor more than 5 % of the gross revenue received for the sale of mineral products or chemical compounds recovered from geothermal fluids. A royalty of 8 % of the net revenue for the operation of an energy producing plant on the leased land. A royalty of not less than 2 % nor more than 10 % of the gross revenue received from the operation of the geothermal resource for recreational, space heating, or health purposes.

Who Does What?

In New Mexico, on federal land, heat is a mineral. On state or private land, it depends on the use and temperature. For example, above 250 °F it is considered a mineral and falls within the jurisdiction of the Oil Conservation Division (**OCD**) for power generation and the Office of the State Engineer (**OSE**) for water adjudicatory issues. Below 250 °F it is still a mineral and falls within the jurisdiction of the New Mexico Environment Department (**NMED**)* for direct heat use when wells are installed and/or the OSE for water adjudicatory issues or when heat pumps instead of wells are used for direct heat or geothermal purposes. Heat is not considered a mineral at all if the geothermal extraction is only incidental to a beneficial use of the water, in which case the water is not considered geothermal and it falls only within the jurisdiction of the OSE.

* Note that oil and gas geothermal co-production technology where the geothermal reservoir temperature is less than 250 °F may also be regulated by the OCD.

The Bureau of Land Management (BLM) Las Cruces District Office has received (June 13, 2011) your Notice of Intent (NOI) to Conduct Geothermal Resource Exploration Operations on military administered land in T. 22 S., R. 7 E.; T 22 S., R 8 E. (Otero County, New Mexico); and T. 25 S., R. 4 E. (Dona Ana County, New Mexico); NMPM.

Based on the information you provided, the BLM has determined that the proposed activities are located within the boundaries of the military reservation established by Public Land Order (PLO) Number 833 (Federal Register May 27, 1952, vol. 17, p. 4822). PLO 833 specifically states that these areas are withdrawn from all forms of appropriation, including the mining and mineral leasing laws, and reserved for the use of the Department of the Army for military purposes. Therefore, provided that any geothermal resources discovered are utilized for military purposes, the Directorate of Public Works may proceed with the proposed exploratory activities. There is no need for BLM approval and your NOI is returned unsigned.

Because the proposed exploratory activity is located on the military reservation, the Directorate of Public Works or other appropriate Department of Defense agency is responsible for compliance with all applicable laws and regulations. These laws could include, but are not limited to, the National Environmental Policy Act of 1969 (42 USC §4321 et. seq.), the National Historic Preservation Act of 1966 (16 U.S.C. 470 et seq.), the Endangered Species Act of 1973 (7 U.S.C. §136, 16 U.S.C. §1531 et seq.), and any applicable State of New Mexico regulations.

The BLM must emphasize that the terms of PLO 833 indicate that any geothermal resources discovered within the military reservation may only be used for military-related purposes. Such purposes could include space-heating of military facilities or generating electricity to be

distributed to military facilities along dedicated power lines. It would not include distributing electricity along power lines owned or operated by civilian electrical utilities or cooperatives.

Our review has determined that the application for lease nomination NMNM 126347 is complete and accurate. For the other seven applications, please make the required corrections listed below and resubmit the nomination forms to the BLM LCDO.

NMNM 126431 and NMNM 126434: The nomination forms contain redundant descriptions of nominated parcels, please remove these redundancies, check total nominated acreage, and recalculate acreage if necessary.

NMNM 126342: all of sections 10, 11 and 12 of T. 21 N., R. 3 E., NMPM, have been nominated. Parts of these three sections were patented with no mineral reservation to the United States. Please refer to the enclosed patents 641154 and 1037851. Revise the descriptions of these nominated lands to eliminate the non-Federal mineral estate. Also, the nominated acreage (4,932.50 acres in section 3a of Form 3203-1) significantly exceeds the described acreage (approximately 4,320 acres, not subtracting the 117.5 acres of non-Federal mineral estate). Please recalculate the acreage or revise the nomination to include lands you may have inadvertently omitted.

NMNM 126343: the nominated acreage (5,119.02 acres in section 3a of Form 3203-1) significantly exceeds the described acreage (approximately 4,520 acres). Please recalculate the acreage or revise the nomination to include lands you may have inadvertently omitted.

NMNM 126345: the nominated acreage (4,983.14 acres in section 3a of Form 3203-1) exceeds the described acreage (approximately 4,480 acres). Please recalculate the acreage or revise the nomination to include lands you may have inadvertently omitted.

NMNM 126346: the total nominated acres (5,118.06 acres in section 3a of Form 3203-1) exceeds the total acreage possible for six nominated sections. Either revise the description to include inadvertently omitted lands, or recalculate the nominated acreage.

NMNM 126348: two of the nominated parcels (W½, sections 24 and 25) are listed in T. 21 N., R. 3 W. All other nominated parcels are listed in T. 21 N., R. 3 E. Is this difference in the range a typographic error, or does ORMAT Nevada, Inc., intend to nominate the Bankhead-Jones Act lands located in the W½, sections 24 and 25, T. 21 N., R. 3 W.?

After the corrected nominations have been received by the LCDO, the BLM will refer all eight nominations to the USFS for concurrence. By regulation (43 CFR 3201.10), the BLM will issue geothermal leases for USFS-administered lands only after receiving concurrence from the Department of Agriculture. If you do not submit corrected nomination forms (BLM Form 3203-1) within 30 days of receipt of this letter, the BLM will close the case files without further action or notification, and return your filing fees.



A map of the proposed leasing area is enclosed with this letter.

The specific activity being proposed is to offer for competitive geothermal leasing approximately 8,329.09 acres of Federal mineral estate. Two separate competitive lease nominations would be

auctioned in block, which means both leases would be awarded to the highest bidder. **Sale of a geothermal lease does not authorize the leaseholder or their operator to begin development activities such as exploratory drilling, roadwork, or facility development; such activities must be authorized separately after the proponent has met regulatory requirements defined in 43 CFR 3200. Furthermore, a separate environmental assessment specific to the location and nature of the proposed lease development activities will be required.**

The proposed leasing area overlaps the Rincon Area of Critical Environmental Concern (ACEC); please refer to the enclosed map. As part of the proposed action, it has been determined by the LCDO District Manager that the area of the Rincon ACEC will be subjected to the No Surface Occupancy (NSO) stipulation. This will effectively close the 840 acres of the Rincon ACEC from any surface disturbing activity associated with the development of lease NMNM 125604.

If the proposed leasing sale proceeds, the competitive lease auction will be held at the LCDO following procedures defined in current BLM regulations (43 CFR 3203). An auction date has not been established, but it is not anticipated that the auction will occur before the summer of 2011. Once issued, a geothermal lease is effective for a primary term of 10 years. The lease may be extended up to 35 years and renewed for up to 55 years provided the leaseholder meets specific development requirements defined in 43 CFR 3207.11 - .16.

The BLM will decide whether to offer all, none, or a subset of the nominated area for competitive geothermal leasing. Should it be determined that competitive leasing can proceed, lease stipulations will be applied to protect surface resources and assure the sustainable development of the geothermal resource. The LCDO encourages you to take this opportunity to comment on this proposal. The LCDO will accept scoping comments until close of business (4:30 p.m.) on **March 14, 2011**. All comments must be submitted in writing to the Las Cruces District Office, 1800 Marquess Street, Las Cruces, NM 88005 and to the attention of Michael Smith.

Before including your address, telephone number, email address, or other personal identifying information in your comment, you should be aware that your entire comment, including your personal identifying information, may be made publicly available at any time. While you can ask us in your comment to withhold your personal identifying information from public review, we cannot guarantee that we will be able to do so.

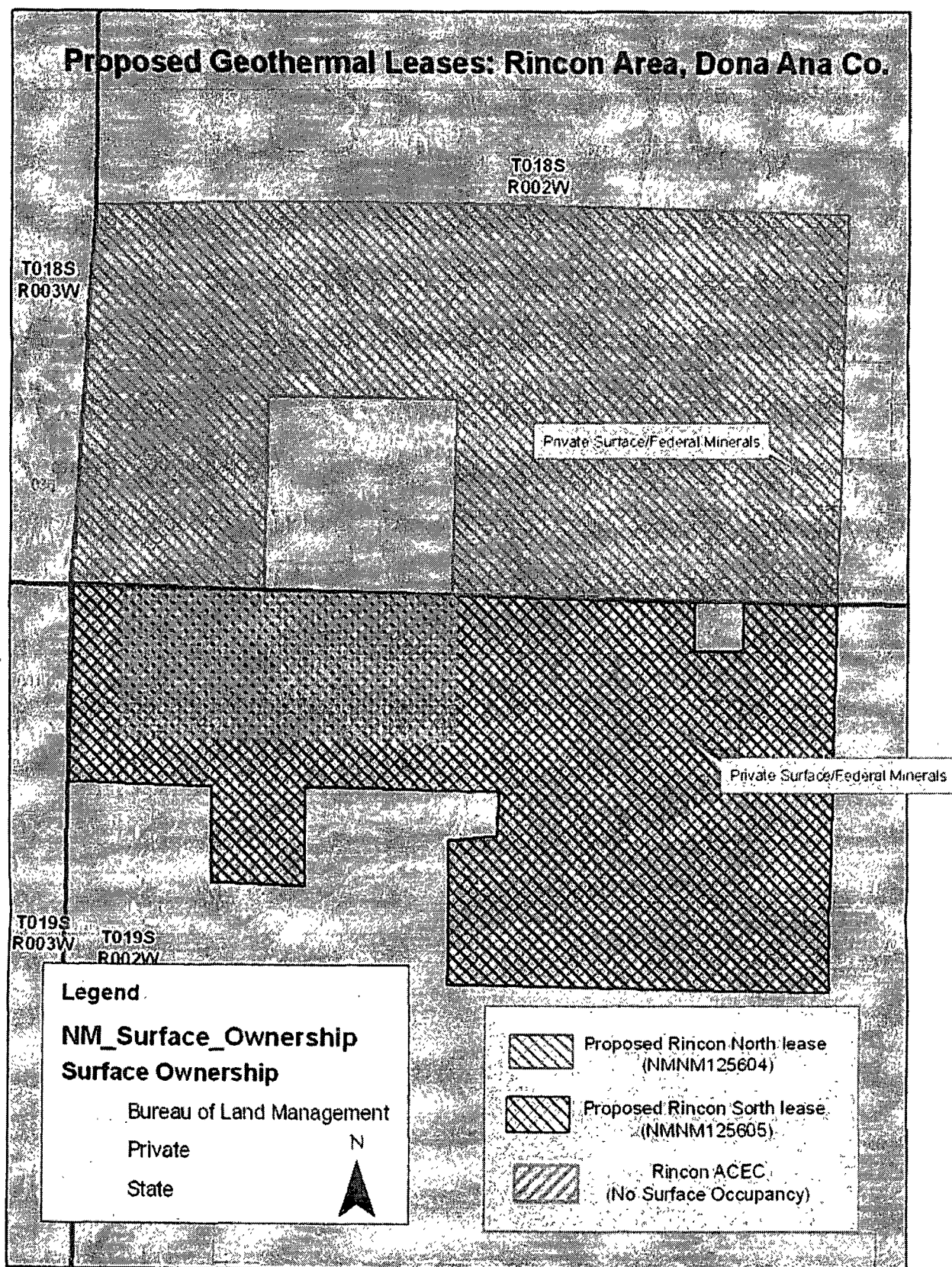

- 1) OCD requests Counsel from RLD to contact Counsel from OCD (Ms. Mikal Altomare) at (505) 476-3480 to discuss the OSE's requirement for NM Certified Water Well Drillers at all Geothermal Projects in NM. The OCD is not sure how this requirement would apply to a high-temperature geothermal environment project?
- 2) OCD is working to update Geothermal Forms G-108 (Monthly Production Report) and G-109 (Monthly Purchasers Report), which may be relied upon by other state and federal agencies for financial assessments. OCD will need to allow agencies that will assess taxes, royalty, etc. an opportunity to review the forms before OCD can finalize them for its website. I have copied the State Land Office (SLO) on this message so it knows the OCD will be sending the forms via e-mail very soon. The Department of Interior has already provided feedback on the forms that will be sent to the SLO. Similar to No. 1 above, Ms. Altomare may be contacted for questions about the forms.

As you can see, we want to know about electricity production, steam or hot water, and if its a direct use facility, then we use different units (ie, hundreds of gallons vs. thousands of pounds or millions of gallons for electricity production):

- 32 Geothermal—electrical generation, thousands of pounds
- 33 Geothermal—electrical generation, MMBtu
- 34 Geothermal—electrical generation, other
- 35 Geothermal—direct utilization, MMBtu
- 36 Geothermal—direct utilization, hundreds of gal
- 37 Geothermal—direct utilization, other
- 38 Geothermal—commercially demineralized water
- 41 Geothermal byproduct—sulfur

I read the section on royalties in your geothermal section. It looks like your Form G-109 is sufficient for reporting byproducts and geothermal resources from wells. However, I did not see a section to report on electricity produced if a company has to pay royalties based on the following: A royalty of 8 % of the net revenue for the operation of an energy producing plant on the leased land.

As far as your Form G-108, someone from BLM would be more qualified than I to comment on production reports.

Carl;

Good morning. Thank you for the update on all your hard work on geothermal, I think its great!

The only thing I am wondering is about geothermal royalties, that being my current area of concentration. I remember that in one of your documents there was a reference to the old Federal direct use royalty calculation method which used two meters, one for input to the facility and one for output after the heat was extracted. That method is no longer in use for new Federal leases.

The new Federal method for direct use is to use only the output meter and assume an input temperature and that the volume is the same before and after extraction. The temperature and volume are then entered into a "fee schedule" and read directly from that, instead of having to do a calculation. Its MUCH simpler.

Likewise, for electrical generation, we now have implemented a "percent of gross proceeds" royalty method for new leases, instead of the cumbersome "netback" method that many of the old leases still use.

I am not aware of how New Mexico is going to calculate/charge for royalties on state leases, for direct use or electrical generation.

If there is any input you would like on that, I would be more than happy to give it.

As for the name of our agency, we have a new one which will be in effect until October 1, at which time it will change again. Right now, our parent bureau has changed from MMS to BOEM (Bureau of Ocean Energy Management, Regulation, and Enforcement). Within that bureau, my division is still MRM (Minerals Revenue Management). Under that, my particular group is RV (Royalty Valuation), under AV, (Asset Valuation), which is under AM (Asset Management) So, the string is: BOEM/MRM/AM/AV/RV.

However, starting October 1, MRM is becoming a separate Office under the Secretary of Interior, called the Office of Natural Resources Revenue (ONRR). We will no longer be a bureau or part of BOEM and will report directly to the Assistant Secretary for Policy, Management, and Budget. No one knows yet, but we assume that my current group will still be AM/AV/RV under ONRR.

There is a schematic attached above.

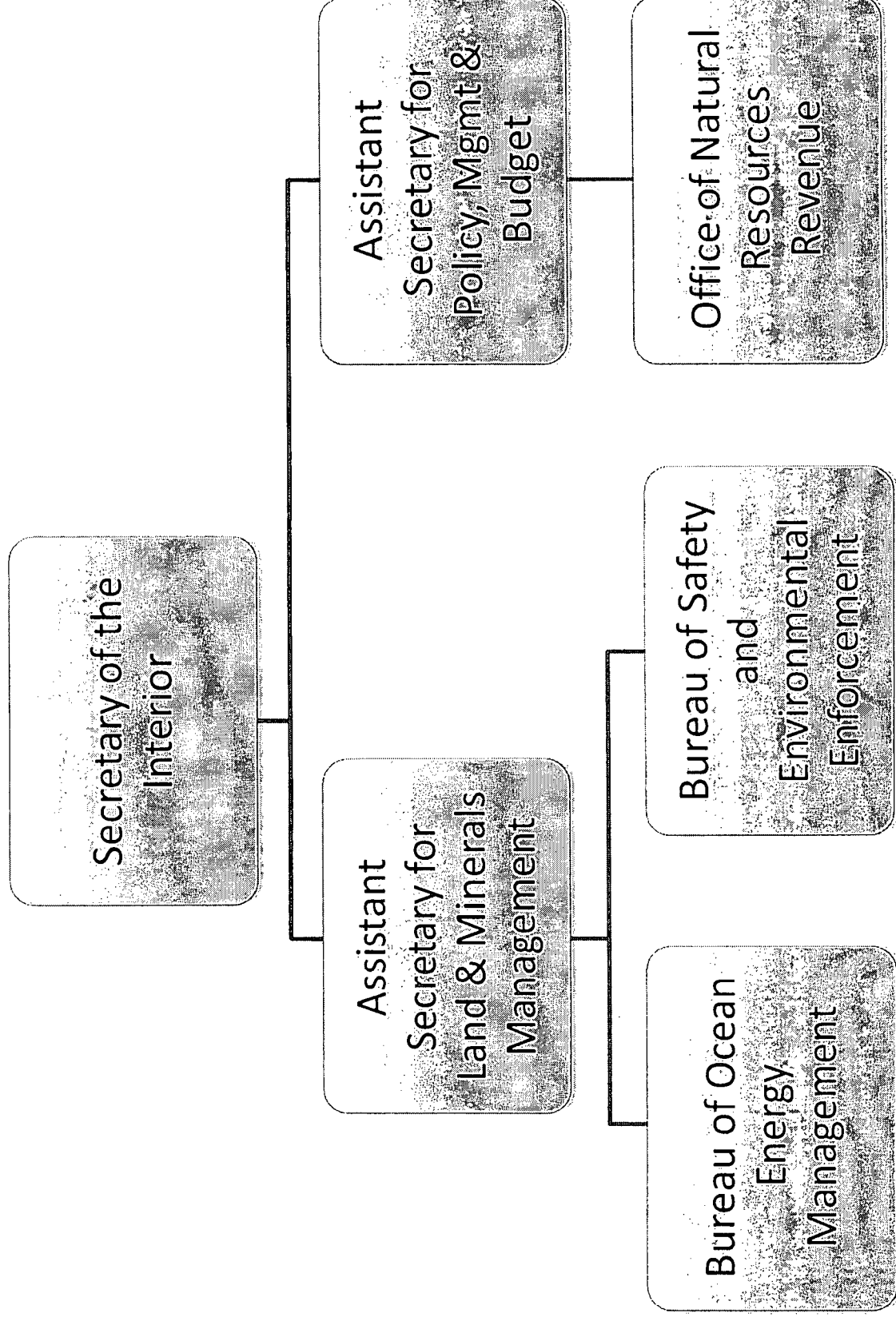

Thanks Carl, it is our pleasure to be involved in whatever way MMS can in New Mexico's geothermal program. I personally am a big fan of geothermal and am endlessly fascinated with how everyone is implementing it. I realize this is a large and complicated feat you are undertaking! As New Mexico has a rather large geothermal potential, I believe this is extremely important work. I did my MS on geothermal geology way back in 1975 and so have a long history with it, both technically and policy-wise.

BTW, I did find an error in the Summary of Discussion from the May 19-20th meeting you had at New Mexico Tech. On Page 7, under the heading "Federal BTU meter requirements" at the top of the page. Turns out Congress did NOT remove the requirement for a BTU meter on direct use facilities. An earlier version of the Energy Policy Act did propose a fee based on acreage, but that was nixed (perhaps due in part to our (MMS) comments against it). We at MMS feel strongly that direct use fees or royalties need to be based on how much heat energy (BTU) (resource) is used, not simply on acreage leased. A small acreage could use much geothermal energy or conversely a large acreage could use little geothermal energy for instance. The MMS Royalty Policy Committee in 2005, of which I was an MMS representative and technical analyst, with the technical help of BLM's Rich Estabrook, came up with the fee schedule now incorporated into the MMS May 2, 2007 geothermal regulations at 30CFR 206.356. This fee schedule for direct use geothermal does require one meter (as opposed to the required two meters under the old MMS regulations for direct use). The operator must input temperature and volume of hot water input to the greenhouse or other direct use facility. Then it's a simple matter of reading the fees from the table. In the past, there was a rather complicated calculation and steam table inputs.

I would be happy to provide an edit for that heading on page 7 if you would like. I am intimately familiar with this issue (and others dealing with geothermal royalties and valuation) because I was the co-author of the 2007 MMS geothermal regulations and worked as part of the "steam team" with the BLM when they also wrote their 2007 geothermal regulations. So if there are any royalty or direct use fee issues or questions I would be very happy to help. I am also the person revising the geothermal Payor Handbook here at MMS to incorporate all the changes from our new geothermal regulations mandated by congress in EAct 2005.

I am attaching a copy of the MMS Royalty Policy Committee (RPC) report from 2005 in which we came up with the direct use fee schedule that is currently in use in our 2007 regulations. This report also recommended a simplified "percent of gross proceeds" royalty calculation method for geothermal electricity projects. This method was also adopted by Congress in EAct 2005 and incorporated in the 2007 BLM and MMS geothermal regulations. Note that Mr. Burgett also participated from New Mexico in the RPC.
