Marbob Energy Corporation requests approval for the Showstopper 17 Federal Com #10H unorthodox location described above. The well is unorthodox because the Bureau of Land Management moved our original location (330' FSL 2310' FEL) to this unorthodox location. The BLM moved the location due to surface issues. This puts the location 150' unorthodox to the north line of the NW/4NE/4 of Sec. 20 T25S R29E and 150' unorthodox to the east line of the SE/4SW/4.

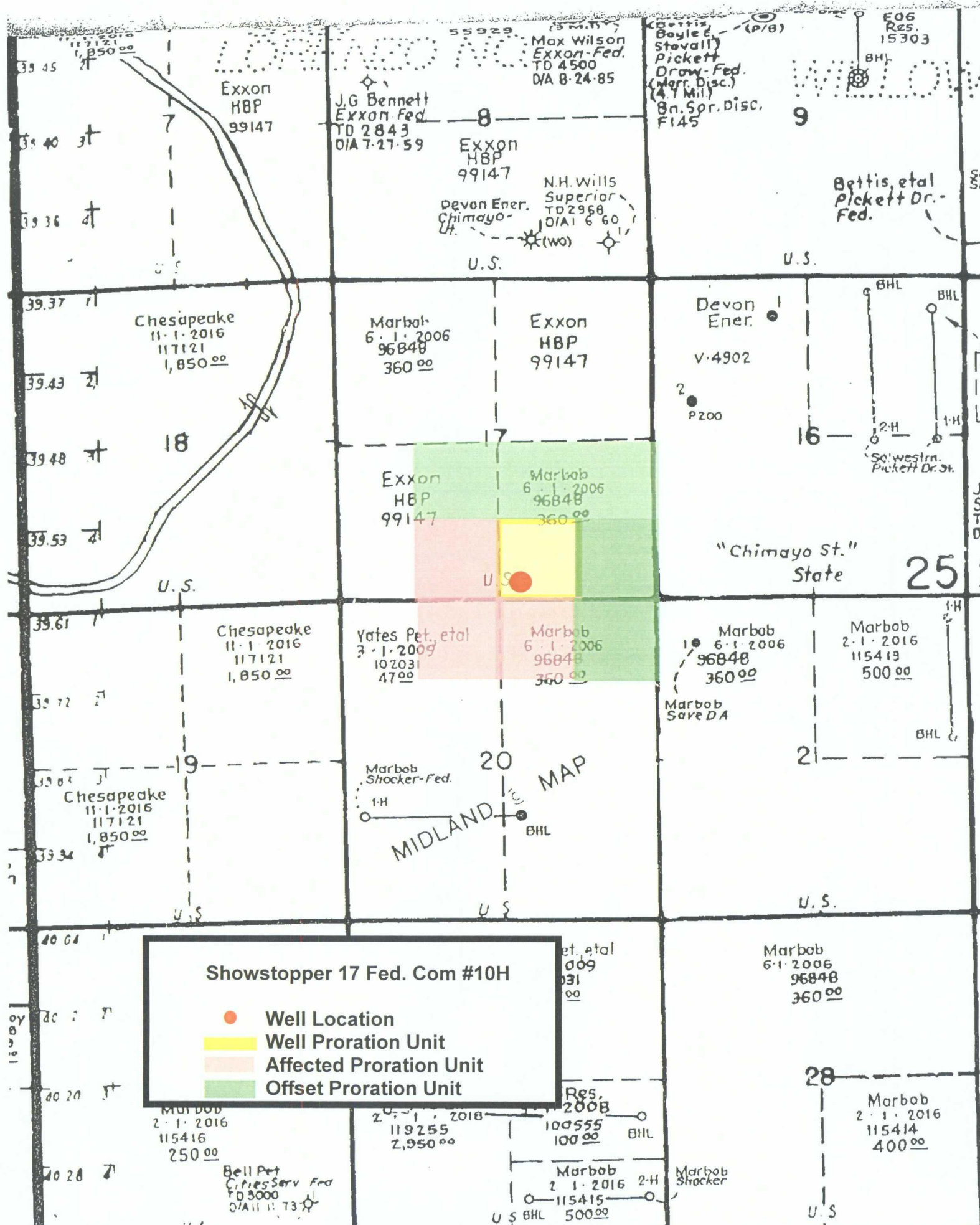

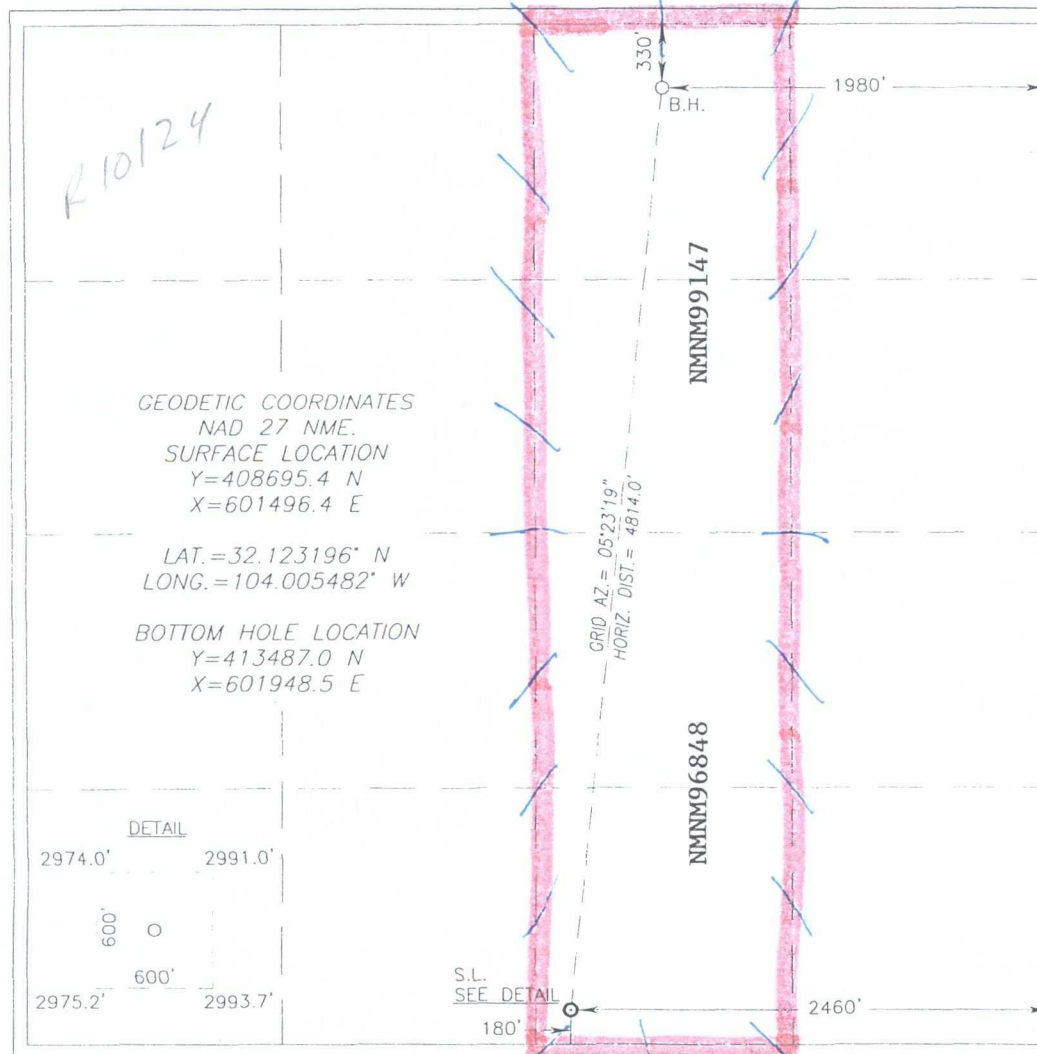
