Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of All (Lots 1, 2, 3, 4, S/2 S/2) of Fractional Section 10, Township 32 North, Range 10 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Stull Pool Unit #1 Well, located 1650' from the South line and 1135' from the West line of Section 10, Township 32 North, Range 10 West, was completed as a gas well from the Mesaverde Formation on July 22, 1956.
2. That the proposed non-standard gas proration unit consists of 344.80 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company is the owner of all the interest in fractional Section 10, Township 32 North, Range 10 West, and that all operators owning interests in acreage offsetting the non-standard proration unit are notified by registered mail of this proposed non-standard gas proration unit.



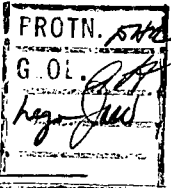

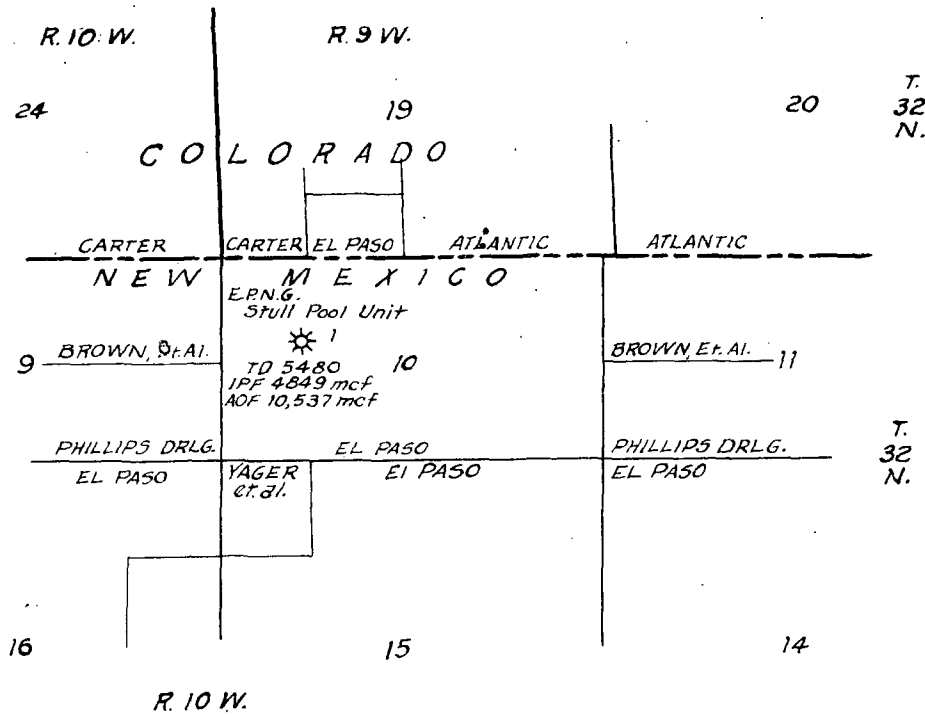
