Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the northeast quarter (NE/4) or (Lots 1,2,7,8) of Section 35, Township 27 North, Range 7 West, Rio Arriba County, New Mexico, and in support thereof states the following facts:

1. The Rincon Unit #41 Well, located 617' from the North line and 1000' from the East line of Section 35, Township 27 North, Range 7 West, was completed as a gas well from the Pictured Cliffs Formation on May 28, 1955.
2. That the proposed non-standard gas proration unit consists of 170.56 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company is the owner of all the interest in Section 35, Township 27 North, Range 7 West, and El Paso Natural Gas Company is the owner of all the interest in acreage offsetting the proposed non-standard proration unit.

Therefore, El Paso Natural Gas Company requests that under the provision of Rule 6(b) Revised of Order No. R-565-C, the Secretary of the Commission grant

exception to Rule 6(a) without Notice and Hearing and approve the subject non-standard gas proration unit.


