Gentlemen:

Please consider this as an application for administrative approval to assign 192.25 acres to our Mexico-Fed "B" well No. 1 gas well, completed in the Pictured Cliffs, and is located 1190' from the south line and 1840' from the west line of Section 9-28N-10W, San Juan County, New Mexico. Section 9 is an abnormal section due to township correction resulting in additional acreage designated as Lots.

Skelly's Mexico-Fed "B" lease contains 192.25 acres which is described as Lots 2, 3, 4 and SW/4 SE/4 and S/2 SW/4 Section 9-28N-10W. We are attaching a photostat of form C-128, which shows the acreage to be assigned to this well. Also we are attaching a plat showing our lease and offset operators.




