On advice from your Aztec office, we are enclosing herewith five copies of Form C-101, "Notice of Intention to Drill" and five copies of Form C-128, "Well Location and Acreage Dedication Plat" on the above referred to proposed well.

It is our intention to drill this well to the Dakota formation and wish to allocate, as the drilling unit, the N/2 of this section. As shown on the Acreage Dedication Plat, the N/2 of this section contains only 291 acres according to the General Land Office Survey.

We respectfully request approval of this application without notice and hearing under Rule 1(b) of the Special Rules and Regulations for the Dakota producing interval.

If approved, we also request you to send the appropriate number of copies to the USGS office since part of this drilling unit is comprised of acreage from Federal Lease No. SF 080956 and being the N/2 of the NE/4 and the SE/4 of the NE/4 of this section.

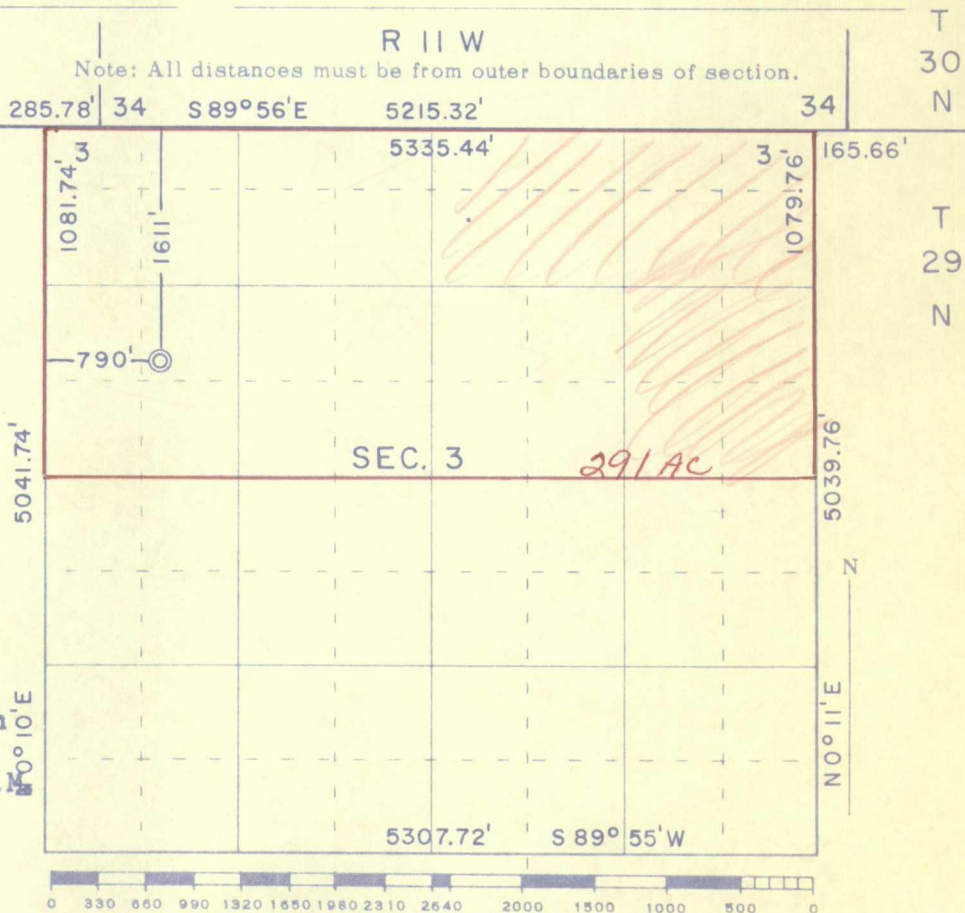
