Dear Sir:

In regard to development operations on acreage adjacent to the Puerto Chiquito Gallup Field, Rio Arriba County, New Mexico, it has been necessary to locate Pan American Petroleum Corporation's Jicarilla Tribal 237 No. 1 on Lot 4 of partial Section 29, T-27-N, R-1-E, to meet offset requirements. Irregularities in the legal subdivision of this section result in four tracts along the south line 801.9 feet in width with each lot containing 24.30 acres.

In accordance with conditions outlined in Paragraph (m) of Rule 104 of the Statewide Rules and Regulations, it is respectfully requested that administrative approval be granted for pooling Lots 3 and 4 to form a non-standard proration unit of 48.60 acres and allow orderly development of Pan American's Jicarilla Tribal Lease Contract No. 237 comprising all of Section 29. For your further consideration the following facts apply: the units involved are contiguous, the units are part of the same basic lease carrying the same royalty interest, and the ownership of the units involved is common.

The Jicarilla Tribal 237 No. 1 well for the proposed unit has been staked at a footage distance of 471.9 feet from the south line and 1295 feet from the west line of Section 29, T-27-N, R-1-E. The location is within 150 feet of the approximate geographical center of Lots 3 and 4 and is no closer than 330 feet to the outer boundaries of the proposed proration unit. Copies of a certified plat showing the well location and acreage involved in the pooling are attached.



Gentlemen:

This will refer to your copy of our letter of September 15, 1960, File: B-2324-400.1, to the New Mexico Oil Conservation Commission requesting approval to pool Lots 3 and 4 of partial Section 29, T-27-N, R-1-E, to form a non-standard proration unit of 48.60 acres for Pan American's Jicarilla Tribal 237 No. 1 in the Puerto Chiquito Gallup Field.

It has been necessary to locate the well on this tract, at a footage distance of 471.9 feet from the south line and 1295 feet from the west line of Section 29, to meet offset requirements of the U. S. Geological Survey for your U.S.A. Alto No. 1 in NW/4 NE/4 Section 5, T-26-N, R-1-E, Rio Arriba County, New Mexico. The pooling of the two lots will avoid the drilling of a well on a 24.30-acre tract and permit an orderly development program on Pan American's acreage in this area.

We have been informed that the New Mexico Oil Conservation Commission will give favorable consideration to our request providing a waiver is obtained from Intex Oil Company stating that you have no objection to the proposed non-standard unit of 48.60 acres for the Jicarilla Tribal 237 No. 1. If this is the case, we would certainly appreciate your sending the Commission such a waiver at your earliest convenience in order that drilling operations can be started with the rig presently available in the area.
