In accordance with Rule 5(B) of the Northwest portion of Order R-1670, El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the E/2 (or Lots 1,2,3,4, NE/4) of Section 15, Township 30 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

- 1. The Howell #3-K Well, located 790' from the North line and 1650' from the East line of Section 15, Township 30 North, Range 8 West, was completed as a gas well from the Mesaverde Formation on November 26, 1951.
- 2. That the proposed non-standard gas proration unit consists of 312.42 acres which are contiguous quarter-quarter sections and lots, as shown by the dependent resurvey of T-30-N, R-8-W which was accepted by the Bureau of Land Management January 19, 1959.
- That the proposed non-standard gas proration unit 3. lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

That by copy of this letter of application all operators owning interest in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit and in acreage offsetting this non-standard proration unit are notified by registered mail of this non-standard gas proration unit.

Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 5(B) of the Northwest portion of Order R-1670, the Secretary of the Commission grant exception to Rule 5(A) without Notice and Hearing and approve the subject non-standard gas proration unit.


