Dear Mr. Porter:

Request is respectfully made to you as Secretary-Director of the Commission to grant an exception to Rule 5A of Order R-1670-C in accordance with Rule 5B without notice and hearing due to the variations in the legal subdivision of the United States Public Lands Survey.

Skelly Oil Company's Jicarilla "B" Well No. 22, located 1850 feet from the north line and 790 feet from the west line of Section 6, Township 24 North, Range 5 West, Rio Arriba County, New Mexico, has been completed as a Basin-Dakota gas well. In accordance with such order we desire to dedicate acreage as the N/2 of Section 6, but due to lots along the north line of Township 24 North, in addition to the normal 320 acres of the N/2 of this section we have Lot 1 in the amount of 12.16 acres, Lot 2 in the amount of 12 acres, Lot 3 in the amount of 11.84 acres and Lot 4 in the amount of 11.68 acres, for a total of 367.68 acres as a non-standard unit.

Attached hereto is a plat showing the names of the offset operators. You will note that the non-standard unit consists of a contiguous quarter quarter sections or lots lying wholly within a single governmental section and is surrounded by producing Dakota gas wells the length or width not exceeding 5,280 feet, and by the hereinafter affidavit that all of the offset operators were notified by registered mail of applicant's intent to form such non-standard unit. Skelly Oil Company owns all of the acreage in Section 6, and the offset operators and their addresses are listed below as receiving copies of this request.




