Dear Mr. Porter:

Pursuant to Rule 5(B) of Order R-1670, Aztec Oil & Gas Company hereby submits its application, in triplicate, for an exception to Rule 5(A) of Order R-1670 and administrative approval of a non-standard gas proration unit consisting of Lots 1, 2, 5, 6 and 7, SW¹₄NE¹₄, W¹₂SE¹₄ (E¹₂) of Section 13, T-31-N, R-12-W, N.M.P.M., San Juan County, New Mexico.

In support of this application, Applicant respectfully states and shows the following:

1. The well to which this non-standard gas proration unit will be dedicated is the Aztec Oil & Gas Company Grenier #12, located seven hundred and ninety feet (790') from the east line and seven hundred and ninety feet (790') from the south line of Section 13.
2. Applicant owns all the acreage within the section on which the non-standard unit is located, as indicated on Exhibit "A" attached hereto. The only operator owning offsetting acreage is L. E. Elliott and he has been furnished a copy of this application with a request that his consent in the form of a waiver of notice and hearing be forwarded to the Commission.
3. The non-standard unit consists of contiguous quarter-quarter sections or lots.

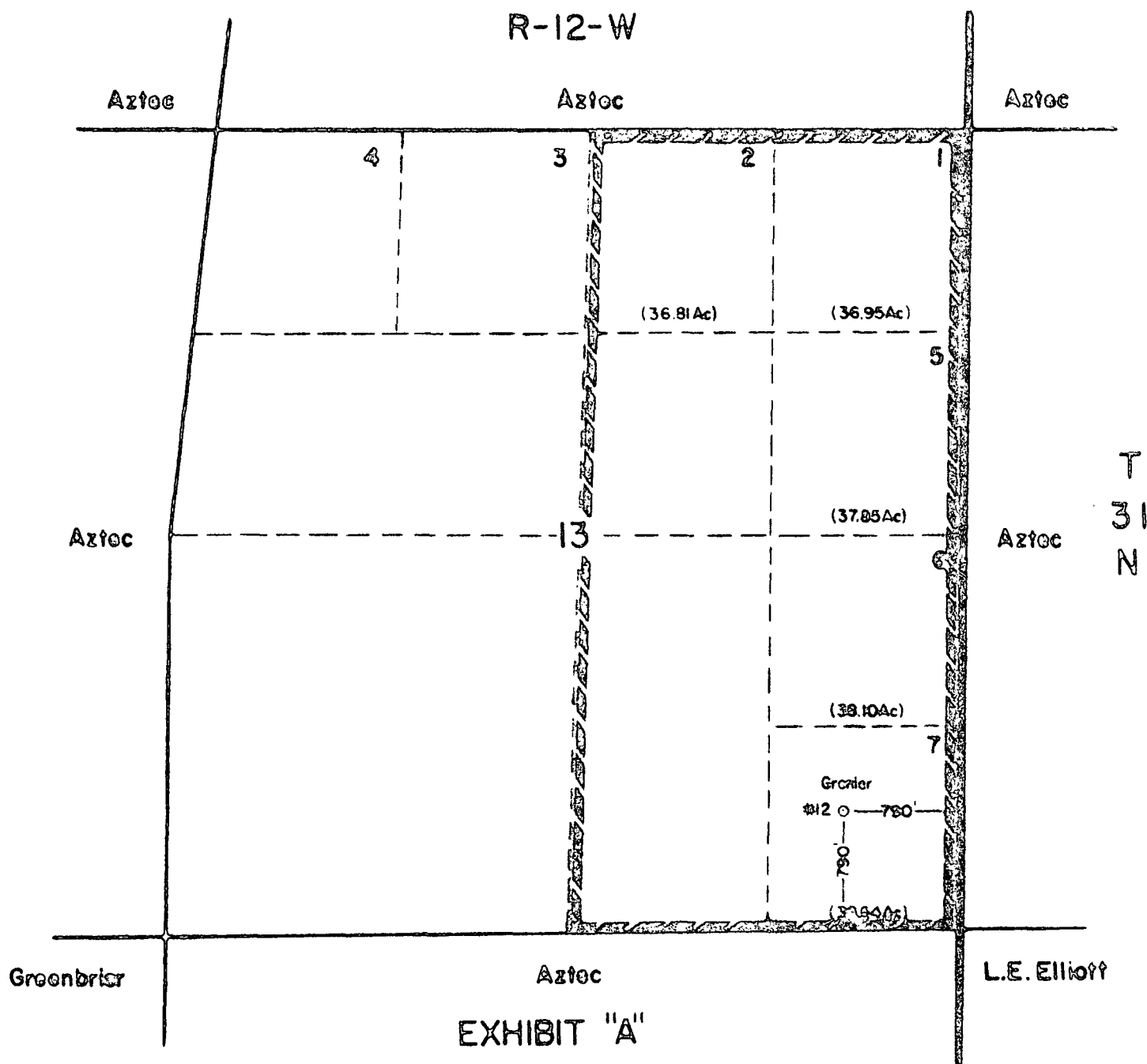
