Burlington Resources requests that the New Mexico Oil Conservation Division establish a nonstandard gas spacing unit within the San Juan 29-7 Unit to be dedicated to any production from the Blanco Pictured Cliffs Pool, to be configured from Lots 10, 11 and 12 and the SE/4NW/4 of Section 6, T29N, R7W, NMPM, Rio Arriba County, New Mexico. This unit is made necessary as a result of variations in the legal subdivision of the United States Public Land Survey. The requested non-standard gas spacing unit is adjacent to the previously approved NSP Order No. R-9303, as shown on the attached map.

Burlington Resources proposes to drill the San Juan 29-7 Unit #188 well to the Fruitland Coal and Pictured Cliffs formation. This well is located 1030' FNL, 900' FWL in Section 6, Township 29 North, Range 7 West. Burlington will apply for a commingle order in the near future. The attached APD lists the spacing unit for the Pictured Cliffs formation as Lots 10, 11, 12, 13 and 14 and the E/2SW/4 and the SE/4NW/4. This spacing unit is being utilized for accounting purposes, according to the San Juan 29-7 Unit Agreement, even though the Blanco Pictured Cliffs pool requires equivalent 160 acre spacing.




