## Gentlemen:

In accordance with Rule 5(B) of Order R-1670-C, Delhi-Taylor Oil Corporation hereby submits its application for administrative approval of the following Non-Standard Proration Unit in the Dakota Formation of the Basin-Dakota Gas Pool. The well name, description of the drilling block, and size of the proration unit covered by this application are as follows:

Delhi-Taylor Oil Corporation has previously filed a Notice of Intention to Drill the above-described well as an Entrada oil test with the designated oil unit as the SE/4 NW/4 of said Section 14. This Notice was dated February 25, 1963, and approved by the proper governmental authorities. It now appears that no successful Entrada completion can be made and the well is presently being completed as a Dakota gas well.

In support of this application Delhi-Taylor Oil Corporation further states as follows:

- The non-standard unit consists of contiguous lots as shown on the attached plat and is an unorthodox size or shape due to a variation in the legal subdivision of the United States Public Land Survey.
- 2. The non-standard unit lies wholly within a single governmental section.
- 3. The entire non-standard unit may reasonably be presumed to be productive of gas.

- 4. The length or width of the non-standard unit does not exceed 5280 feet.
- 5. Enclosed is a written waiver and consent from El Paso Natural Gas Company the operator of all off-set acreage including the remaining portion of the section.

Accordingly, Delhi-Taylor Oil Corporation requests that under the provisions of Rule 5(B) of Order R-1670-C the Secretary of the Commission grant exception to Rule 5(A) without Notice and Hearing and approve the W/2 of Section 14, T30N-R8W, San Juan County, New Mexico, containing 294.88 acres, as the Non-Standard Proration Unit for the Florance Federal No. 50 Well.
