Gentlemen:

In accordance with Rule 5(B) of the Northwest portion of Order R-1670, El Paso Natural Gas Company, as Operator, hereby submits its application for administrative approval of the following Non-Standard Proration Unit in the Mesaverde Formation of the Blanco-Mesaverde Gas Pool. The well name, description of the drilling block and the size of the proration unit covered by this application is as follows:

4. The length or width of the non-standard unit does not exceed 5,280'.
5. There are no offset operators to the above described non-standard unit who own Mesaverde rights. El Paso is the sole interest owner within the section.



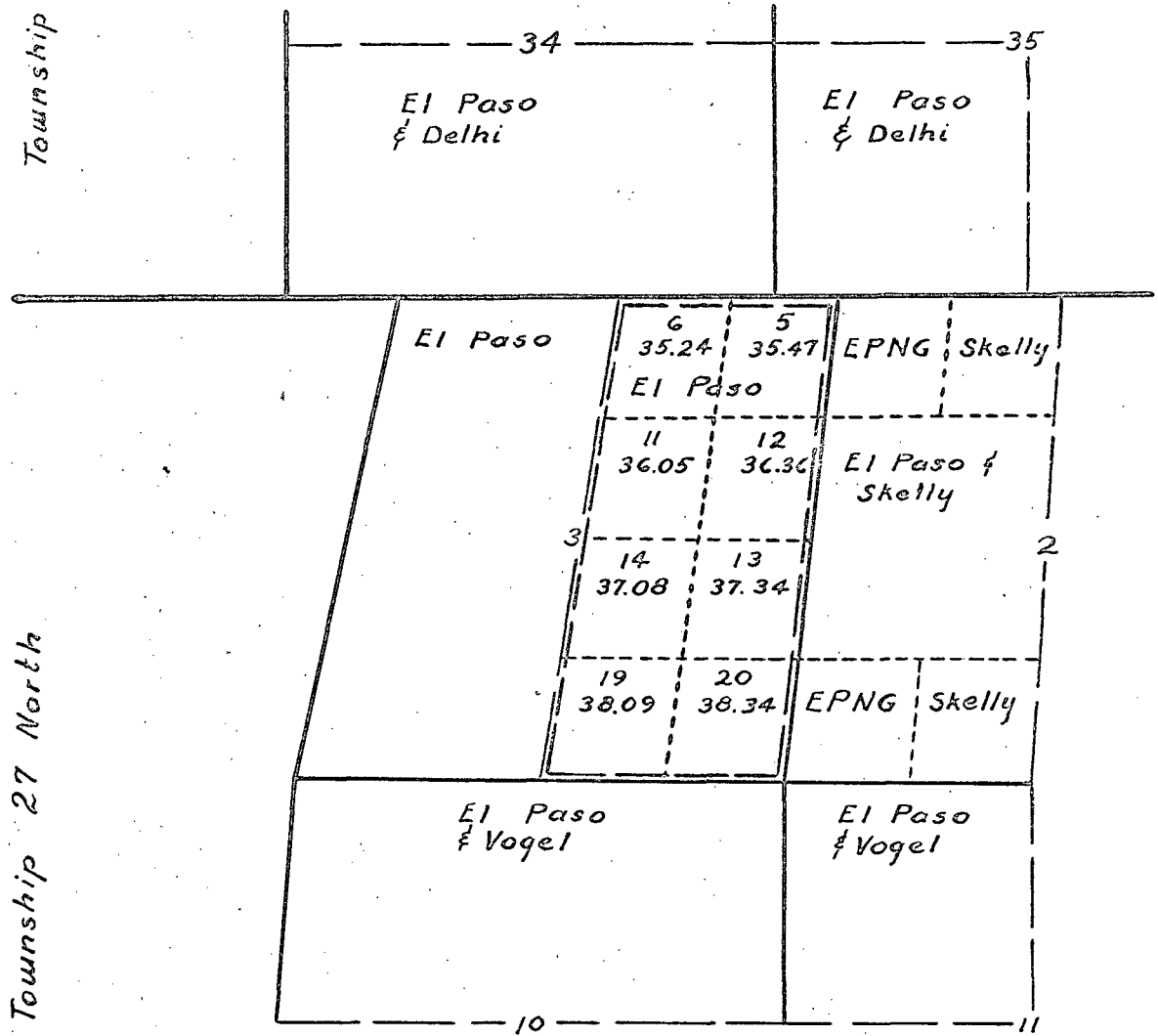
