Gentlemen:

In accordance with Rule 5 (B) of Order R-1670 covering North-western New Mexico, El Paso Natural Gas Company, as Operator, hereby submits its application for administrative approval of a non-standard proration unit consisting of Lots 3, 4, N/2 SE/4 (SE/4) Section 33, Township 28 North, Range 8 West, N.M.P.M., San Juan County, New Mexico and in support thereof states the following facts:

- ✓ 1. That the proposed non-standard gas proration unit consists of 148.18 acres which are contiguous quarter quarter sections and lots.
- ✓ 2. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- ✓ 3. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- ✓ 4. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this non-standard gas proration unit.

Therefore El Paso Natural Gas Company requests that under the provisions of Rule 5(b) of Order R-1670 covering Northwestern New Mexico, the Secretary of the Commission grant exception to Rule 5(A) without Notice and Hearing and approve the subject non-standard gas proration unit.
