(ARCADIS) respectfully submits this Well Plugging Report for the above-referenced site per NMOCD's August 16, 2010 notification that the remediation plan is terminated in accordance with 19.15.30.29B NMAC, and request for a final well plugging report. Monitoring wells (MW-1, MW-2, MW-3, MW-4, and RW-1) were plugged on September 14, 2010 with a cement grout containing 1% to 3% bentonite and a three foot cap of cement at the surface. 
