Plains' respectfully requests NMOCD approval to modify the previously approved April 2008 *Soil Closure Proposal* for the subject site. The requested modification consists of performing the following activities during the soil remediation phase of the project:

- Expose groundwater in the bottomhole of the excavation, most likely in the vicinity of recovery wells RW-1 and RW-2
- Utilize a vacuum truck to recover impacted groundwater

- Dispose of the recovered groundwater off-site at an approved disposal facility
- Backfill and compact the areas of exposed groundwater to a level of 20' below ground surface (bgs) with clean soil (<100 mg/kg TPH concentrations) after the completion of recovery efforts
- Proceed with the installation of the synthetic liner in the bottomhole of the excavation as per the April 2008 *Soil Closure Proposal*
- Include a description of the groundwater recovery activities performed at the site in the forthcoming soil remediation summary report
