Dear Mr. Jones,

Apache Corporation respectfully requests approval to re-extend Administrative Order SWD-860, permission to recomplete the Argo No. 7 (API 30-025-09915) to inject produced water into the San Andres formation. This order expired on November 21st, 2003 and we wish for it to be extended for 1 year.

Apache proposes to begin work as soon as approval for this project is granted.

After original approval was granted for Administrative Order SWD-859 (Argo No. 6) and 860, the Argo No. 6 was converted to inject produced water in the San Andres. Prior to any work beginning on the Argo No. 7, Apache began a study to convert this well into a Ellenburger formation disposal well instead of the originally planned San Andres formation SWD well. Unfortunately the permit period expired before this examination was completed. Ultimately, Apache has made the decision to follow the original plan and convert the Argo No. 7 into a San Andres formation SWD well.

Your consideration in approving this Administrative Order extension for the Argo No. 7 well is greatly appreciated.
