Dear Sir:

It is requested that the Secretary-Director of the New Mexico Oil Conservation Commission grant an exception to Rule 309(a) to permit the commingling of production from State Lease B-10920 (as to the SE/4 SW/4 Section 2, Township 17 South, Range 31 East) now in production, and State Lease B-3635-37 (NE/4 SW/4 Section 2, Township 17 South, Range 31 East) which will be drilled in the near future.

These leases are contiguous and the production will be from the same common source of supply. The ownership of the leases is common throughout.

By copy of this letter we are requesting permission to commingle production from these two leases from the State Land Commissioner and from the adjoining land owners.

Register return receipts will be forwarded when received from adjoining land owners.


