The above named company is hereby authorized to commingle North Young Bone Spring Pool (65350) production from the following leases:

Lease: Federal 'AM' Lease (Federal Lease No.NM-18232)
Description: NW/4, and,

Lease: Federal 'AF' Lease (Federal Lease No.NM-40448)
Description: E/2 SW/4 ,

both located Section 8, Township 18 South, Range 32 East, NMPM, Lea County, New Mexico.


Production shall be allocated to each lease by separately metering all production prior to commingling.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled production shall be stored in the Federal 'AM' tank battery facility located in Unit Letter 'F', Section 8, Township 18 South, Range 32 East, NMPM, Lea County, New Mexico.

FURTHER: The operator shall notify the Hobbs district office of the Division prior to implementation of the commingling process.

Mr. Catanach:

Burlington Resources Oil & Gas Company respectfully requests approval for Off-Lease Storage, Measurement of Hydrocarbons, and Off-Lease Storage for the Federal AM Lease (NM18232) and the Federal AF Lease (NM40448), all of which are located in Section 8, T18S, R32E, Lea County, New Mexico. All production is from the North Young Bone Spring pool.

All the production is stored in the Federal AM battery. This facility consists of two 500 bbl closed top tanks for oil storage, and one 500 bbl closed top tank for water production. As indicated by the enclosed schematic, production from the Federal AF lease is transported via above ground poly line into a separate heater treater. The production from the Federal AM lease is transported via the same method to another heater treater. Prior to entering the main line to the battery, production is measured by means of a 'one barrel dump pot' which counts the production and registers it. Gas from each lease is separately metered prior to entering the main gas meter line. Water is stored into the one tank and subsequently trucked.


All working interest owners have been notified of the commingled facilities.

The proposed commingling of production is in the interest of conservation and will not result in reduced royalty or improper measurement of production. The proposed commingling is necessary to continue operations for the above referenced leases. Due to the low volumes on the Federal AF lease, there was no economical way to justify building a separate battery.

The Bureau of Land Management was notified by certified mail on April 30, 1997.
