Marathon Oil Company respectfully requests the State of New Mexico Oil Conservation Division to grant administrative approval for exemption to Rule 309-A for the attached referenced leases and above referenced pools. The Buchanan '33' St. lease, Samuel Burns '34' St. lease, David Crockett '27' St. lease, Henry Courtman '4' St. lease, James Garvin '22' St. lease, J. Guerrero '34' St. lease, Edward Mitchusson '4' St. lease, George Pagan '26' St. lease, and W.B. Travis '15' St. lease are currently commingled per Order No. CTB-467 as a multiple lease, single pool (Travis Upper Penn - 59860) order. Marathon is requesting approval for a multiple lease, multiple pool order on the aforementioned leases and the above referenced pools.

Marathon Oil Company has proposed to produce the Travis Upper Penn to a central battery located at the J. Buchanan 33 St. No. 1 location per commingling Order No. CTB-467. The proposed system was developed utilizing satellite testing and lease metering facilities with the liquids sent to the central battery for disposition and the gas sold on lease. Unfortunately, not all wells drilled in this ongoing field development have been economically productive in the Travis Upper Penn. For this reason, additional zones of interests are being tested.

Since it has become necessary to complete zones in addition to the Upper Penn, it is now necessary to amend commingling Order No. CTB-467 to include the Travis Wolfcamp Wildcat (96833). Surface commingling of produced fluids from multiple horizons is required to economically produce the current horizons being tested in this development. We however assure you that the existing and planned production facilities located at each lease, and at the central battery, will provide for the accurate determination and allocation of production from each production well and each productive horizon. Please note the proposed amendment will remain in accordance with the applicable provisions.

Marathon is proposing the generalized Travis Upper Penn and Travis Wolfcamp lease commingling to help alleviate the need for numerous, replicating commingling amendments as it becomes necessary to complete additional Wolfcamp wells in this Travis Field development.

Marathon is also requesting that the Oil Conservation Division apply the State Land Office and working interest owner's approvals concerning the August 19, 1998, Travis Upper Penn, Travis Wolfcamp Wildcat, Illinois Camp, N. Morrow, Illinois Camp Morrow, and Turkey Track, N. Morrow application. By applying the previous approvals to this less inclusive Travis Upper Penn and Travis Wolfcamp Wildcat application, an additional 20-day application delay period will not be necessary.
