Dear Mr. LeMay:

In order to avoid considerable expense in constructing and maintaining two separate tank batteries for the above lease, Arch Petroleum Inc. hereby seeks an exception to Rule 303A. This will allow Arch to commingle production from the Teague Blinbry and Langlie Mattix Pools. All wells will be tested periodically for allocation of production.

The attached tabulation shows the volumes, gravities and monetary values of the liquid hydrocarbons from individual pools, as well as commingled production. The tabulation also shows total average daily production for a 2 month period. The calculated revenue from the commingled production is the same as the price on the individual pools.

Also attached is a schematic diagram of the storage facilities for the commingled production and a lease plat. Basis Petroleum Inc. has agreed to purchase the commingled production as proposed herein.

The commingling proposal is in the interest of conservation in that it prevents unnecessary waste and production expense.


Dear Ms. Brooks:
