APPLICATION OF CITIES SERVICE OIL COMPANY TO EXPAND ITS WATER FLOOD PROJECT IN THE CAPROCK-QUEEN POOL IN LEA AND CHAVES COUNTIES, NEW MEXICO.

### ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-1128-B, Cities Service Oil Company has made application to the Commission on August 12, 1959, for permission to expand its Water Flood Project in the Caprock-Queen Pool, Lea and Chaves Counties, New Mexico.

NOW, on this 15th day of September, 1959, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Order No. R-1128-B.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-1128-B.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
  - 6. That the application should be approved.

### IT IS THEREFORE ORDERED:

That the applicant, Cities Service Oil Company, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

Government "B" Well No. 17 located in NW/4 NW/4 of Section 10 and Government "B" Well No. 21 located in NW/4 SW/4 of Section 3, both in Township 14 South, Range 31 East, NMPM, Chaves County, New Mexico.
