ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Cities Service Petroleum Company has made application to the Commission on March 7, 1962, for permission to expand its Drickey Queen Sand Unit Water Flood Project in the Caprock-Queen Pool, Chaves County, New Mexico,

NOW, on this 12th day of March, 1962, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been fully notified of the application.
3. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
4. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
5. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Cities Service Petroleum Company, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

Tract 11, Well No. 3, NW SE, Section 11, Township 14 South,
Range 31 East,
Tract 28, Well No. 1, SE SW, Section 35, Township 13 South,
Range 31 East
Tract 48, Well No. 1, NW NW, Section 15, Township 14 South,
Range 31 East
Tract 48, Well No. 3, NW NE, Section 15, Township 14 South,
Range 31 East
Tract 48, Well No. 5, NW NW, Section 14, Township 14 South,
Range 31 East
