ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Leonard Nichols has made application to the Commission on August 10, 1963, for permission to expand its Boller-Nichols Water Flood Project in the Maljamar Pool, Lea County, New Mexico.

NOW, on this 19th day of August, 1963, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That waivers of objection have been received and the vaiting period as prescribed by Rule 701 may be dispensed with at this time.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
 - 6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Leonard Nichols, be and the same is hereby authorized to inject water into the Grayburg formation through the following described wells for purposes of secondary recovery, to wit:

Iles Well No. 26 located in the SE/4 NE/4 of Section 10, Iles Well No. 28 located in the NW/4 SE/4 of Section 10, Taylor "E" Well No. 2 located in the NW/4 SW/4 of Section 11, and Taylor "E" Well No. 3 located in the SW/4 SW/4 of Section 11, all in Township 17 South, Range 32 East, NMPM.

Provided However, That applicant shall inject fresh water only down the 5½ inch casing and other than fresh water through tubing with packers set well below the top of the cement surrounding the 5½ inch casing in said wells.

Done at Santa Fe, New Mexico, on the day and year hereinabove designated.
