Dear Sir:

We hereby request administrative approval to convert West Loco Hills Unit Well No. 19B-4 to water injection in the Loco Hills Sand Unit Waterflood. This well is located 2310' from the North line and 2310' from the East line of Section 19, T18S, R29E, Eddy County, New Mexico.

The waterflood was authorized under Commission Orders R-2178-B, and R-2178-C. This well is located in Stage V of the development.

A diagrammatic sketch is attached showing the casing run in the well and the cement used. Also attached is a map showing the location of this well.
