ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Newmont Oil Company has made application to the Commission on August 23, 1973, for permission to expand its Young (Queen) Water Flood Project in the Young-Queen Pool, Lea County, New Mexico.

NOW, on this 7th day of September, 1973, the Secretary-Director finds:

- That application has been filed in due form.
- That satisfactory information has been provided that all offset operators have been duly notified of the application.
- That no objection has been received within the waiting period as prescribed by Rule 701.
- That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
- That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
 - That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Newmont Oil Company, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

> Well No. 14 located in Unit B and Well No. 16 located in Unit E, both in Section 20, Township 18 South, Range 32 East, NMPM.

PROVIDED HOWEVER, that the applicant shall inject water through tubing with packers set at approximately 3730 feet and 3634 feet, respectively.
