ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2635, Texas American Oil Corporation has made application to the Commission on March 1, 1976, for permission to expand its Harlan-Queen Waterflood Project in the Grayburg-Jackson Pool, Eddy County, New Mexico.

NOW, on this 16th day of March, 1976, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Order No. R-2635.
- 4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-2635.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
 - 6. That the application should be approved.

That the applicant, Texas American Oil Corporation, be and the same is hereby authorized to inject water into the Queen formation through plastic-lined tubing set in a packer at approximately 1800 feet in the following described well for purposes of secondary recovery, to wit.
