ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order F-4027, Depco, Inc. has made application to the Commission on April 12, 1976, for permission to expand its Camp Artesia Water Flood Project in the Artesia Pool, Eddy County, New Mexico.

NOW, on this 27th day of April, 1976, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-4027.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-4027.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Depco, Inc., be and the same is hereby authorized to inject water into the Grayburg and San Andres formations through plastic-lined tubing set in a packer at approximately 2450 feet in the following described wells for purposes of secondary recovery, to wit:


State 647 Well No. 84 located in Unit L of Sec. 27,  
State 647 Well No. 85 located in Unit G of Sec. 33,  
State 647 Well No. 205 located in Unit A of Section 33,

all in Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico, and through plastic-lined tubing set in a packer at approximately 2600 feet in the following described well:

State 647 Well No. 89 located in Unit K of Section 27,  
Township 18 South, Range 28 East, NMPM, Eddy County,  
New Mexico.
