ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-2210, Atlantic Richfield Company has made application to the Commission on October 24, 1966, for permission to expand its Horseshoe Gallup Unit Pressure Maintenance Project in the Horseshoe-Gallup Oil Pool, San Juan County, New Mexico.

NOW, on this 13th day of November, 1966, the Secretary-Director finds:

- 1. That application has been filed in due form.
- 2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
- 3. That no objection has been received within the waiting period as prescribed by Order No. R-2210.
- 4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-2210.
- 5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
 - 6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Atlantic Richfield Company, be and the same is hereby authorized to inject water into the Gallup formation through the following described wells for purposes of secondary recovery, to wit:

Unit Well No. 10 located in the SE/4 NE/4 Section 30 and Unit Well No. 12 located in the SE/4 SW/4 of Section 29, both in Township 31 North, Range 16 West, NMPM, and Unit Well No. 73 located in the SE/4 NE/4 Section 14, Township 31 North, Range 17 West, NMPM.

PROVIDED HOWEVER, That applicant shall complete and operate the above described wells as outlined in the application for conversion dated October 21, 1966.
