Maintenance Project


Gentlemen:

By Order No. R-1745 dated August 9, 1960, the Oil & Gas Conservation Commission approved Humble Oil & Refining Company's application for a pressure maintenance project in the Horseshoe Gallup oil pool, San Juan County, New Mexico. Special rules to govern the project were adopted, including Rule 11, which provides for expansion of the project after filing an application with certain required information and obtaining approval of the application by the Secretary-Director of the Commission.

By administrative approval of an application from Humble Oil & Refining Company on September 8, 1960, the injection project was expanded to include an additional 160 acres; namely, the Navajo Lease described as the NE/4 of Section 5-31N-17W, Tribal Lease No. 14-20-603-65.

It is hereby requested that the Commission approve the drilling of an additional injection well to be located 1050 feet from the North line and 1050 feet from the East line, Section 5-31N-17W. In accordance with Rule 11 of Order No. R-1745, attached is a plat showing wells and offset operators and a schematic drawing of the proposed injection well. By copy of this letter all offset operators are notified of this injection well application at the addresses shown on the attached.

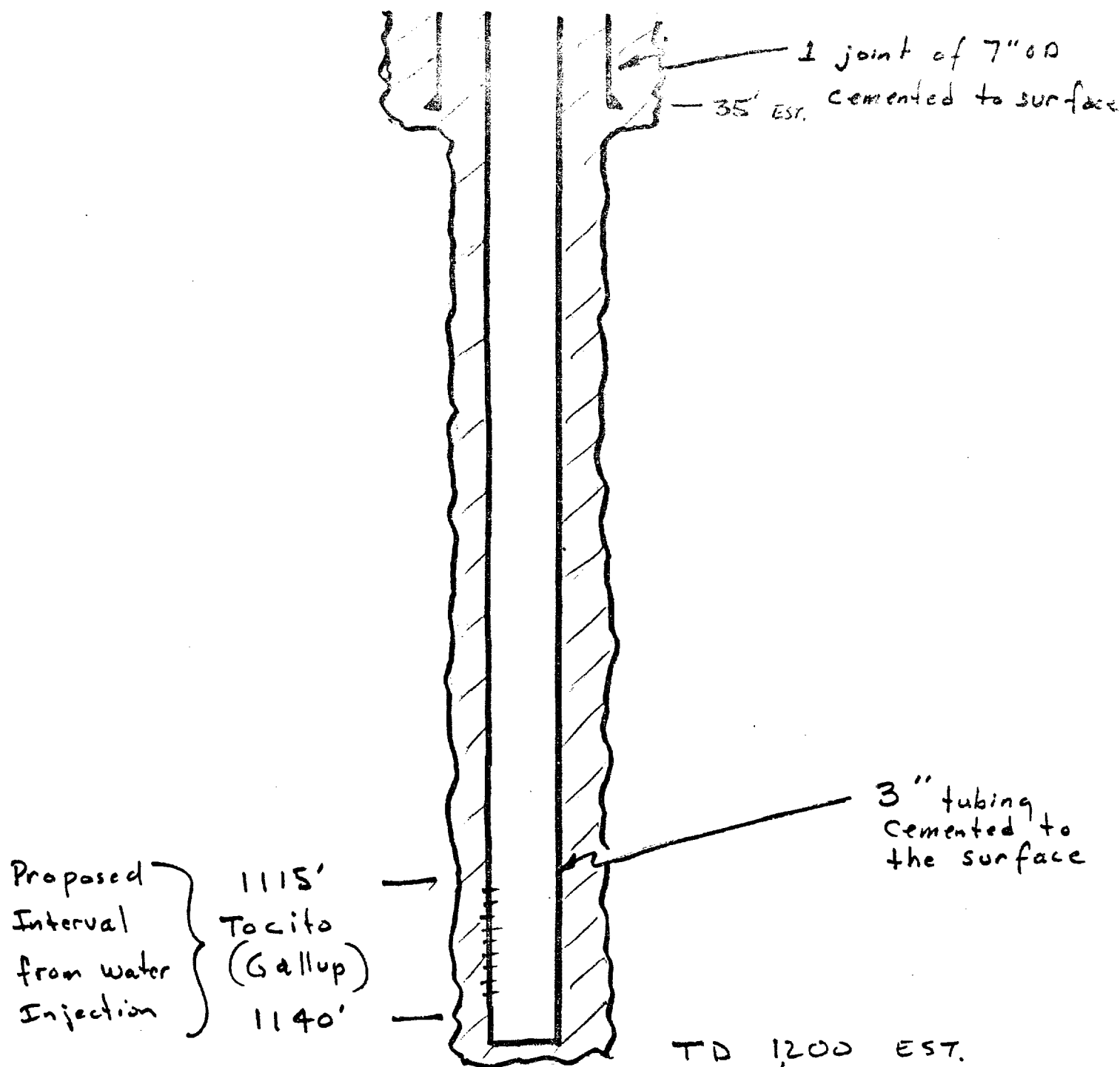
