ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4549, Atlantic Richfield Company has made application to the Commission on March 26, 1975, for permission to expand its Empire Abo Unit Pressure Maintenance Project in the Empire-Abo Pool, Eddy County, New Mexico.

NOW, on this 10th day of April, 1975, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-4549.
4. That the proposed injection well is eligible for conversion to gas injection under the terms of Order No. R-4549.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, Atlantic Richfield Company, be and the same is hereby authorized to inject gas into the Abo formation through the following described well for purposes of pressure maintenance, to wit:

Empire Abo Unit Well No. H-19,
located in Unit O, Section 36,
Township 17 South, Range 27 East,
