Gentlemen:

The twelfth revision of the Niobrara-Greenhorn participating area for the Cañada Ojitos unit agreement, Rio Arriba County, New Mexico, was approved on January 11, 1974, by the Acting Oil and Gas Supervisor, U. S. Geological Survey, effective as of August 1, 1972.

The twelfth revision adds 11,523.22 acres as described on page 1 of the attached application, thereby enlarging the Niobrara-Greenhorn participating area to 52,992.56 surface acres. Such revision is based on the information obtained by the completion of unit well O-9 in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ sec. 9, T. 26 N., R. 1 W., N.M.P.M., on August 13, 1972. The commercial ability of such well was substantiated by your supplemental data of December 28, 1973.

Copies of the approved application are being distributed to the appropriate Federal offices and two copies are returned herewith. You are requested to furnish all interested parties with appropriate evidence of such approval.
