

SUBJECT: SALT WATER DISPOSAL WELL

ORDER NO. SWD-215

THE APPLICATION OF MERRION & BAYLESS
FOR A SALT WATER DISPOSAL WELL

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION DIVISION

Under the provisions of Rule 701 (C), Merrion & Bayless made application to the New Mexico Oil Conservation Division on October 3, 1979, for permission to complete for salt water disposal its Navajo H-13 located in Unit K of Section 13, Township 29 North, Range 14 West, NMPM, San Juan County, New Mexico.

The Division Director finds:

(1) That application has been duly filed under the provisions of Rule 701 (C) of the Division Rules and Regulations;

(2) That satisfactory information has been provided that all offset operators and surface owners have been duly notified; and

(3) That the applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 (C) will be met.

(4) That no objections have been received within the waiting period prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant herein, Merrion & Bayless, is hereby authorized to complete its Navajo H-13 located in Unit K, Section 13, Township 29 North, Range 14 West, NMPM, San Juan County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the Cliffhouse Mesaverde formation at approximately 2490 feet to approximately 2520 feet through 2 3/8 inch plastic lined tubing set in a packer located at approximately 2480 feet.

IT IS FURTHER ORDERED:

That the operator shall take all steps necessary to ensure that the injected water enters only the proposed injection interval and is not permitted to escape to other formations or onto the surface.

That the casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of leakage in the casing, tubing, or packer.

That injection pressure shall not exceed 500 pounds per square inch as measured at the surface.

That before the Merrion & Mayless Navajo H-13 may be converted to injection the Merrion & Bayless Navajo H-3 in Unit O of Section 13, Township 29 North, Range 14 West, must be adequately cemented across and above the Cliffhouse Mesaverde zone in such a manner to ensure the presence of cement throughout the Cliffhouse Mesaverde formation and a minimum of 500 feet above the top thereof.

That the operator shall notify the supervisor of the Division's District Office before injection is commenced through said well;


That the operator shall immediately notify the Supervisor

of the Division Aztec District Office of the failure of the tubing, casing, or packer in said well or the leakage of water from or around said well and shall take such steps as may be timely or necessary to correct such failure or leakage.

PROVIDED FURTHER: That jurisdiction of this cause is hereby retained by the Division for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after notice and hearing, the Division may terminate the authority hereby granted in the interest of conservation. That applicant shall submit monthly reports of the disposal operations in accordance with Rule 704 and 1120 of the Division Rules and Regulations.
