Enclosed is the data requested under paragraph VI of our application for salt water disposal approval. This data was inadvertently left out of the original application package mailed February 9, 1993.

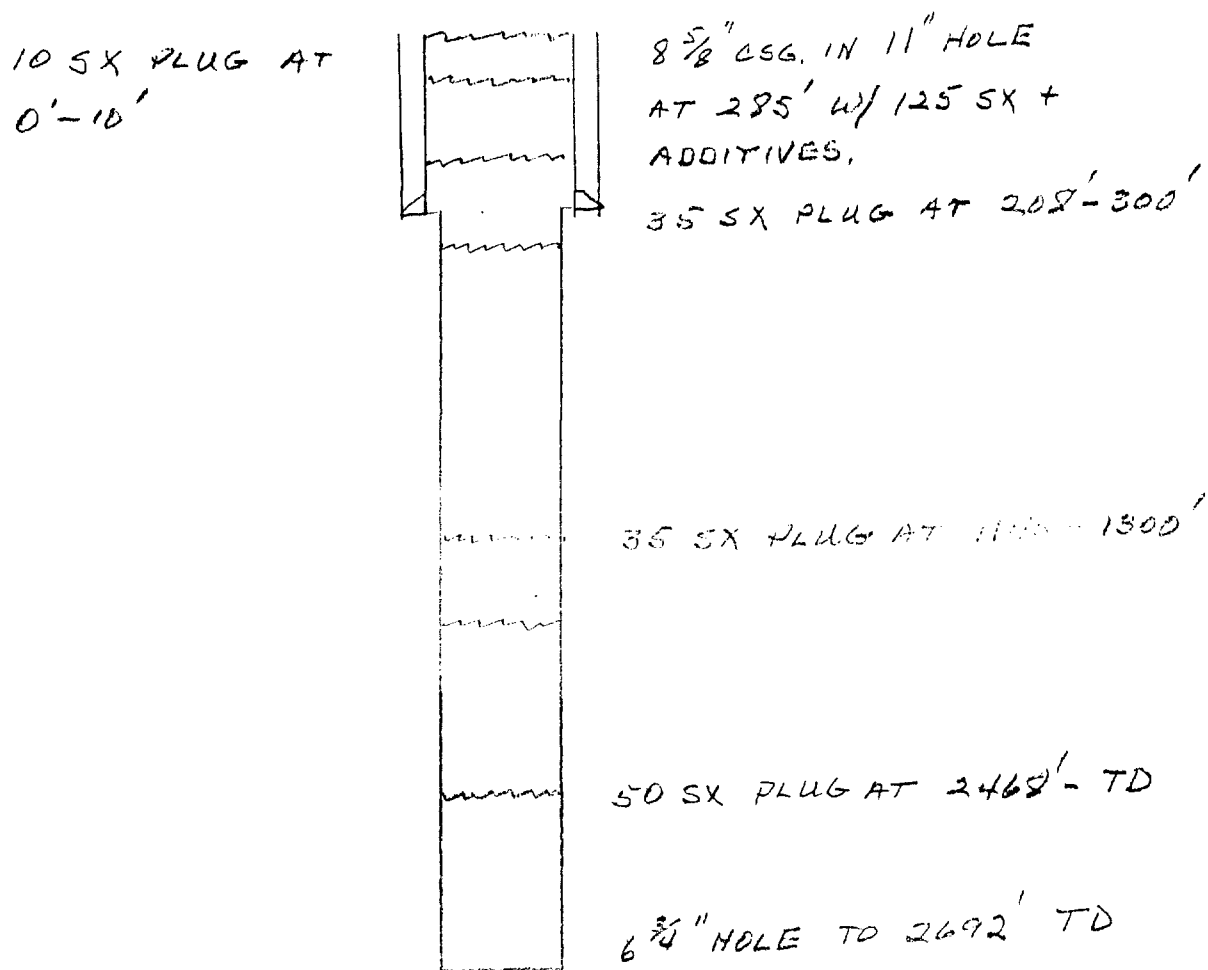
