On behalf of Nadel & Gussman Permian, LLC, I recently submitted a C-108 to convert the State HH #12 to a saltwater injection well. Approval of the C-108 was granted and Permit #696 was issued.

In the original C-108 the injection tubing was to be 2 3/8" plastic coated tubing. We would now prefer using 2 7/8" cement or plastic lined tubing. The reasons for this requested change are:

- 1. The larger tubing will have less friction and result future power cost savings.
- 2. Nadel & Gussman currently have some 2 7/8" tubing in stock.
- 3. Larger tubing will allow greater daily rates to be injected if the injection horizon will accommodate the volumes.
