Dear Mr. Ashley:

Marathon Oil Company respectfully requests administrative approval to permit the surface commingling of production in the above mentioned pools. The L. G. Warlick 'C' Well No. 7, was recently recompleted to the Penrose Skelly Grayburg. Future plans are to recomplete the L. G. Warlick 'C' Well No. 8 to the Grayburg.

Marathon Oil Company has a 70.5% Working Interest in the above mentioned lease. Letters have been sent to all Working and Royalty Interest Owners. We proposes to utilize the L. G. Warlick 'C' storage and sales facility for both oil and gas. Since the wells/pools are marginal, the production will be determined from periodic well test. The proposed production operation is in accordance with the applicable provisions.

The commingling of these pools will save approximately \$22,000 from not needing to add a second header, heater treater & separator for the sour production stream (these includes credit/charges for changing out the

2 phase separator for a 3 phase separator). Whether the pools are commingled or not, we will incur some cost to add ground level gauges to the stock tank with sour oil. The reduction in revenue by commingling these pools is estimated to be \$404/month, based upon the current oil and gas production (sweet wells) from Well No. 5 & 6. These calculation also are based upon the current differential in sour to sweet crude of \$3/bbl and gas of \$0.03/mcf.

Please find attached a lease plat, well plat and a production facility schematics. The Ellenburger production of (3 BOPD @ 38 API, 85 MCFPD) is currently valued at WTI crude price. Grayburg is currently testing at (10 BOPD @ 36 API, 20 MCFPD) and will be valued at WTS crude price. Only gas is produced from the Simpson at (64 MCFPD). The commingled estimated production of (13 BOPD @ 36.5 API, 173 MCFPD) is anticipated to be valued at WTS crude price.

If not Commingled, estimated gross revenues:

From Well No. 5 & 6 (WTI) ; 90 BOPM @ \$31.45/BO = \$2830

From Well No. 7 (WTS) ; 300 BOPM @ \$28.45/BO = \$8535

From Well No. 5 & 6 ; 4470 MCFPM @ \$3.40/MCF = \$15,198

From Well No. 7 ; 600 MCFPM @ \$3.37/MCF = \$2022

Total revenue from oil = \$28,585

If commingled, estimated gross revenues:

From Well No. 5, 6 & 7 (WTS) ; 390 BOPM @ \$28.45/BO = \$11,095

From Well No. 5, 6 & 7 ; 5070 MCFPM @ \$3.37/MCF = \$17,086

Total revenue from oil = \$28,181

The difference in revenue from oil will be \$404 / month.
